Benchmark: FTSE 3 Month US T-Bill Index

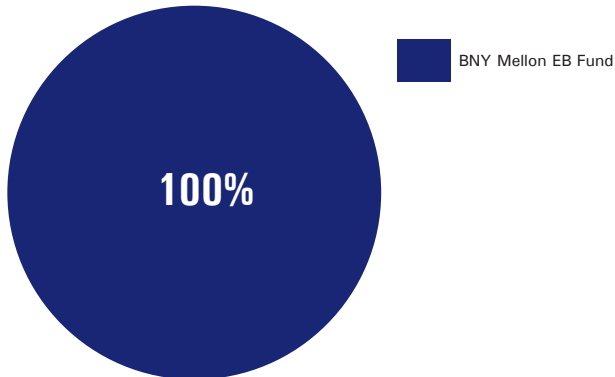

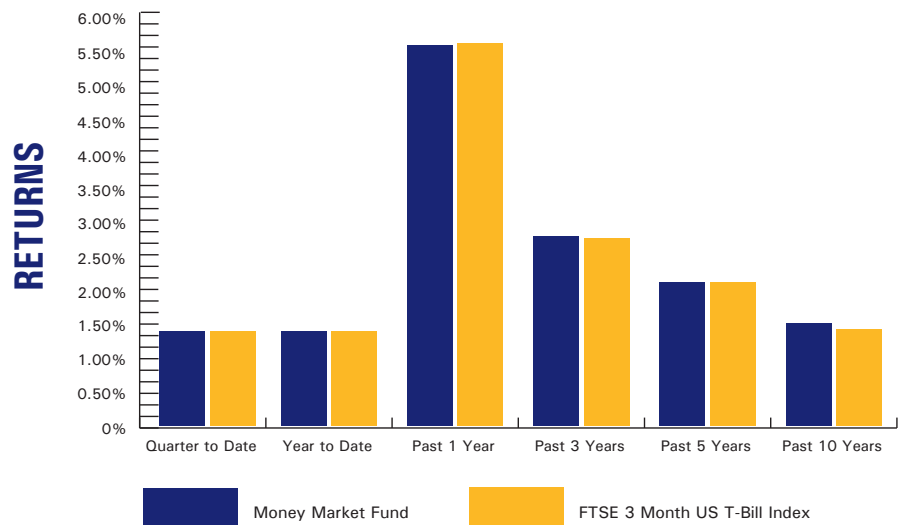
