Juvenile Report IPDC Board Retreat, September 18-19, 2020

The bulk of the juvenile work, separate from helping with legislative liaison activities, consists of working with state and non-profit organizations, technical assistance and training for attorneys to promote juvenile defense as a specialized areas of the law, and outreach to "students" committed to the DOC for juvenile offenses or as a result of alternative sentencing for adult convictions.

# **Professional Organization Partnership Work:**

IPDC and its staff are frequently asked to consult or assist with juvenile related work by state and federal agencies, non-profits, and other organizations. Here are some examples:

Provided technical assistance for and presented at the Juvenile Competency Roundtable held on September 13, 2019, by the Children's Policy and Law Initiative of Indiana. Followed up with a presentation on proposed statutory language on September 2, 2020.

Represented Indiana at the National Juvenile Defender Center's Annual Leadership Summit held October 25-27, 2019.

Represented Indiana at the convening of the Great Lake States Region for the Juvenile Law Center on issues related to emerging adult justice reforms on December 10-11, 2019.

Participated in the Indiana Juvenile Detention Alternatives Initiative's (JDAI) Conditions of Confinement Workgroup and its review of facility responses regarding compliance to JDAI standards (on going).

We will be working with the Council for State Governments on the review of data collection in juvenile justice, spearheaded by Rep. McNamara, and Sen. Crider.

Served as local counsel for the Juvenile Law Center in *C.J. v. State*, 141 N.E.3d 830 (Ind. Ct. App. 2020), *trans. denied*. Favorable decision for child, suppressing statement even after Miranda Warnings, and parent consultation.

In addition to this, IPDC also collaborated with Indiana Department of Child Services to present training on juvenile delinquency proceedings, CHINS/TPR proceedings, and their intersection in proceedings involving dual status children for Legislative Services Agency attorneys and others on November 13, 2019.

### **Technical Assistance:**

IPDC staff attorneys participate on a weekly basis in contributing to questions and concerns which are submitted on the "Jdlaw" list serve. Most of the responses and contributions to this list serve are not formally tracked.

IPDC also receives specific requests for technical assistance, which it recently began tracking through a new system created by Salesforce. Since starting tracking in 2019, IPDC has responded to twenty-for formal requests for technical assistance involving the defense of juveniles. In addition, IPDC participated in oral argument mooting and brain storming sessions for 4 appellate cases involving the defense of juveniles.

The recent Supreme Court decision in *D.P. v. State*; *State v. N.B.*, Case No. 20S-JV-443 (Ind., Sep. 8, 2020), started as a response to a request for technical assistance. IPDC drafted the motion to dismiss for lack of jurisdiction for a

defender in Putnam County, which ultimately resulted in the Supreme Court decision (along with N.B.'s case).

#### **DOC Orientation and Interviews**

As a part of the outreach program created by the Juvenile Project, IPDC began a process of legal rights orientations at the Indiana Department of Correction, Division of Youth Services (DOC DYS) intake facilities. Since April of 2017, IPDC, and the prior Juvenile Defense Project, has met with approximately 1,250 kids committed to the DOC, conducted individual interviews/consultations with 628 of those kids upon request, and referred 80 kids to the State Public Defender's Office to investigate claims not appropriate for direct appeal, and 126 kids for direct appeals.<sup>1</sup> Additionally, a few kids have been helped with other things such as making reports of abuse or neglect upon their request, and connecting them with civil rights attorneys.
