ERIC KOSELKE RE NOT ATTENDING BD MEETINGS AND HIS POSITION ABOUT BEING ON BOARD. BOARD ENCOURAGED CHAIRPERSON TO EMPHASIZE NEED FOR BOARD ATTENDANCE...MINUTES APPROVED WITH AMENDMENT.

2. EXECUTIVE DIRECTOR'S REPORT:

A. DISCUSSION ON 96-97 GOALS AND 97-99 GOALS.

B. CAN BEGIN WORKING ON MANUALS FOR EVIDENCE AND PRE-TRIALS

YR...RECENT DEVELPMTS: BLOOMINGTON AND PARK CO HAVE PLANS THOUGH NOT YET APPROVED; FULTON CO IN PROGRESS WITH JUDGE BUT NO BD IN PLACE YET; LAKE CO IS WORKING AND "ON CUTTING EDGE."

DISCUSSION RE COMPUTERS AND SYSTEM...INTERNET ONLY WAY TO GO...REMOTE SYSTEM RESEARCH NOT WORTH MONEY; CAN DO ALL BUT MICHE LAW ON DISC; \$5 PER YEAR TO CREATE OWN IN DEPT SECURITY...EVERY PERSON WILL HAVE TO BUY LOCAL ACCESS TO GET INTERNET...COST AVERAGING \$20 AROUND STATE; OTHER OPTION TO SET UP TI LINE AND SET UP WEBSITE IN OFFICE...THERE ARE LOTS OF INITIAL COSTS AND NOT ENOUGH IN HOUSE KNOWLEDGE REQUIRED...INITIAL COSTS APPROX. \$10,000 PLUS SEVERAL UNKNOWN COSTS AND LOTS OF LABOR TIME.

OLD SYSTEM: PROBLEMS...SO MANY VARIABLES IN ATTEMPTING TO MAINTAIN OLD SYSTEM...SOFT WARE PROBLEMS, TOO LABOR INTENSIVE, AND THUS COSTS TOO GREAT TO MAINTAIN.

INTERNET: NONE OF AFOREMENTIONED PROBLEMS. USER GROUP WOULD INCLUDE ALL PDS WHO SUBSCRIBE; MAY CREATE A PAGE FOR CAPITAL CASES, IND'L'S MAIL ADDRESSES...PROBLEM: NOT AS SECURE AS BULLETIN BOARD. EG WHEN P.D. MEMBER LEAVES AND BECOMES PROSECUTOR...LAG TIME TO GET OFF SYSTEM 6 MOS. COST TO MEMBER: FOR SHORT TERM \$5 PER PERSON...BILLING TO BEGIN 1/1/97 THUS 6 MOS FREE. IF WANT TO BUILD A WEB SITE NEED A SEPARATE FEE...SUBSCRIBER RATE \$20 PER YEAR.
