INDIANA PUBLIC DEFENDER COUNCIL Board of Directors Meeting August 21, 1981

MINUTES

The meeting of the Board of Directors of the Indiana Public Defender Council was held at the Brown County Inn, Town Hall Room East, in Nashville, Indiana on August 21, 1981 at approximately 5 p.m.

- 1. Members Present were Tom Cone, Mark McNeely, Daye Keckley, Joe Williams, Terry Richmond, Larry Combs.
- 2. Staff Members Present were Larry Landis, Executive Director, and Mary Sinnock, Administrative Assistant.
- 3. Approval of Minutes. Minutes of the preceding meeting of the Board of Directors on June 29, 1981, were submitted by Mary Sinnock, and approved.
- 4. Election of Officers.

Chairman: Larry Combs was nominated by Mark McNeely, seconded by Joe Williams. Larry Combs was elected Chairman by affirmation.

Vice Chairman: Mark McNeely was nominated by Joe Williams, seconded by Terry Richmond. Mark McNeely was elected Vice Chairman by affirmation.

Secretary: Terry Richmond was nominated by Tom Cone, seconded by Dave Keckley. Terry Richmond was elected Secretary by affirmation.

5. New Business

- 1. Appointment of Programs and Publications Committee and Legislation Committee. Larry Landis informed the Directors that he had solicited volunteers for the two committees during his announcements at the beginning of the seminar program, and again at the annual meeting held earlier that day. Members were asked to sign up on sheets provided at the registration desk. Larry Combs volunteered to represent the Board on the Committees and said he would enlist other Directors after seeing how many volunteers signed up.

- 3. Ratification of hiring James Cupp as Research Director. Larry Landis gave the Directors background information about James Cupp and his experience and qualifications for the position. The Directors approved his hiring as Research Director.
- 4. Mary Sinnock asked the Directors if they wished to take any action in response to the death of Harriette Bailey Conn, Public Defender of Indiana. The Board expressed their desire to send flowers or a contribution from the Council if Council funds could be used for this purpose. Tom Cone offered to compose a memo for the record (and the next Indiana

Defender issue), in appreciation for Mrs. Conn's contributions to and service on the Indiana Public Defender Council.

6. Next Meeting of Directors. It was agreed that the next meeting of the Board of Directors will be held just prior to the next seminar, November 6, 1981, at the Airport Holiday Inn in Indianapolis, if there is sufficient business to call for a meeting.

Larry Combs said that he would call a meeting of the Programs and Publications Committee within the next month.
