6. 1992 LEGISLATION

The board took the following positions:

Supported: life without parole; competence to stand trial; children's testimony, closed circuit only; discretionary license suspension in drug cases, preliminary hearing to challenge probable cause, abolish GBMI, or in alternative, parity in bail right, right to appeal suppression on guilty plea, state compliance with federal juv. jail removal req. (assuming reasonable draft).

No position: multiple victims, hate crimes.

Opposed: consecutive sentencing; child molesting amendment.

OLD BUSINESS

The Board approved adding the Canadian indigent defense voucher system to the list of options available to counties in the process of selecting their indigent defense delivery system.
