

## INTEGRATED PUBLIC SAFETY COMMISSION SYSTEM KEY AGREEMENT

## Memorandum of Understanding (MOU)

## **AGREEMENT AND TERMS OF USE**

Agencies agree to the following terms and conditions when accepting a system key for the IPSC P25 system:

- 1. A current Memo of Understanding (MOU) must exist between the accepting agency and the Integrated Public Safety Commission (IPSC). A change in agency authority will require a new MOU with the Integrated Public Safety Commission.
- 2. Once activated, the Hardware System Key is operational for a period of twelve (12) months.
- 3. **SPECIAL NOTE**: Effective January 1, 2020 IPSC will activate agency keys for the IPSC P25 system only. Any additional systems appended to the key must be added by the associated agency.
- 4. Effective January 1, 2020, Hardware System Key updates will be performed <u>by appointment</u> at the IPSC Communications Technical Center (CTC). This new process will provide improved service and convenience to our customers.

  - b. Appointments will be scheduled with IPSC Communications Analysts at the IPSC CTC in Indianapolis.
  - c. Allow approximately one (1) hour for your appointment.
  - d. Please remember to bring your current IPSC Users Agreement/Memorandum of Understanding (MOU) and Hardware System Key.
- 5. In accepting a Hardware System Key the agency agrees to the following:
  - a. Agencies are responsible for all costs incurred for the replacement of lost, stolen, or expired Hardware System Keys.
  - b. Agencies agree to immediately notify IPSC of lost or damaged system keys.
  - c. Agencies agree to maintain their system keys in a secure location and will not release or loan them to third parties.
  - d. Agencies must assure that unauthorized programming and use of their assigned Hardware System Key does not occur.
  - e. Unauthorized or inappropriate use of hardware keys will result in the cancellation of this agreement and loss of key privileges.
  - f. All radio programming personnel <u>must</u> provide a copy of their CPS certificate to the Integrated Public Safety Commission.
  - g. Agencies agree to use standardized talk-group alias naming conventions to prevent confusion when operating with other agencies.
  - h. Agencies may program their radios with talk-groups from within their local jurisdiction with written permission from the affected agencies.
  - i. To maximize interoperability, agencies should program statewide, regional and event mutual aid talkgroups into their radios.
  - j. IPSC reserves the right to reject, recover and cancel hardware keys.
