# INDIANA GRAIN INDEMNITY BOARD OFFICIAL MEETING MINUTES

Chairman Robert Benson called the annual meeting of the Indiana Grain Indemnity Corporation Board of Directors to order at 10:04 a.m. on November 16, 2004. The meeting was held in the Board Room on the seventh floor of the Indiana Farm Bureau Corporate Headquarters located at 225 South East Street, Indianapolis, Indiana.

**QUORUM:** Chairman Benson stated that there was a quorum present.

First order of business was introductions of Board members and guests. Others present were:

MINUTES: Copies of the minutes of the previous meeting (May 27, 2004) were mailed to board members. Correction were brought to the Board's attention. Under **New Business**: the word Cooperation should be Cooperative. Under **Adjournment** the statement should have started **It was motioned.** On the Statement of Operations, the last line, **Fund Balance** should be dated 4/30/04. J. Colvin moved to dispense with the reading of the minutes and approve them as admended. (Second from H. Rettinger) **The minutes of the May 27, 2004, meeting were approved as amended.** 

**FINANCIAL:** The next order of business was the financial report prepared by Duane Jasheway on October 31, 2004, disclosing a fund balance of \$13,177,457.76. Along with the balance sheet was a statement of operation and a listing of fund investment information. Copies were distributed (Exhibit A). D. Jasheway stated that the average rate of return is averaging approximately a 1.75% yield for the fund. Motion by R. Hadley was made to accept the financials as they were presented and certify the amount of the fund is \$13,177,457.76 as of November 1, 2004. (Second from J. Rulon) *The motion was carried and the financial statements were approved and the amount of the fund on November 1, 2004 was certified to be \$13,177,457.76*.

**OLD BUSINESS:** Chairman Benson gave the Board an update on the federal preemption rule to the board and gave them the history of the progress. At this time the progress is at a stand still. He also updated the board on Citizen's Grain failure. He stated that the business was sold and IGBWLA is continuing to monitor and if there is a bankruptcy IGBWLA will file.

Chairman Benson also noted to the board that he is preparing listings of items and timelines regarding duties the board performs as an example board term expirations.

**NEW BUSINESS:** Bill Johnson gave the board a summary on his recent conference regarding Electronic Warehouse Receipts. Chairman Benson reported to the Board that bonding changes had been made in the 1999 statute amendment that will affect Grain Bank, Warehouse and Buyer/Warehouse licensees. IGBWLA has changed all forms involved and letters and new for will go out December 1, 2004 beginning with the January fiscal year ends. Approximately 80% of these licensees will be affected.

A discussion evolved regarding confidentiality and how the IGBWLA handled this. The board was asked to direct all matters concerning this topic to the agency.

The Annual Board Meeting date was selected to be Thursday, May 26, 2005.

**ADJOURMENT:** It was motioned that the meeting adjourn by L. Rulon. (Seconded by R. Hadley) The meeting adjourned at 10:58 a.m.
