I. 9:13 AM: Call to Order

II. Draft Minutes of July 2010

Bob Eddleman moved to approve the July 2010 minutes as presented. Bill Mann seconded and the motion carried.

III. Clean Water Indiana

a. 2010 and Prior Grants Paul Hoffman- See Attachment

Paul Hoffman reported the 2006 grants are completed. All districts have sent in final reports. One district will be returning funds to us. The 2007 grants are completed. Hoffman reported some of the 2008 grant funds that were unused will be reverting back to Cigarette Tax Fund. Hoffman reported the 2009 grants have a balance of \$8372; 18 districts have sent in final reports and 5 districts with amendments will be submitting final reports ASAP.

b. 2011 Grants Program- Nathan Stoelting

Due to many numerous questions regarding the \$1,000 incentive, Nathan requested clarification for districts. Warren Baird and Nola Gentry discussed requirements for the use of those funds and concluded as long as a portion of the incentive is used in a multi district project, the balance could be spent in other areas as listed in the grant, excluding training. As a reminder, the 2011 Grant Requests are due October 15. Bob Eddleman moved the Grants Committee be empowered to receive, review and award grants and report results in November SSCB meeting. Larry Clemens seconded the motion; motion carried.

c. CREP- Sara Christensen—See Attachment

i. CREP Update and Report

All 11 watersheds are now eligible for CREP signup. Attached report does not show obligated; only paid contracts, broken down by practice. Sara noted frequency of practices in each watershed are available in attached report. Staff is now using SharePoint for CREP reporting. Noted changes to CREP: CP23 and CP23A will be altered to ensure higher level of wetland protection. CP21 will use the 393 specs.

ii. CREP Local Administration

All SWCDs will be using SharePoint for CREP reporting. Partnership trainings will occur in October with round table discussions broken up by watershed. There will be 2 dates; one north and south. Funding for each watershed will be based on eligible acres

d. CWI Budget- Jerod Chew

Previous staff switch has been approved and implemented. CWI now supports 11 staff. The current appropriation for CWI is 3.6M. The State is requiring a 15% reserve. Clemens asked if reserve can be used if necessary. Pinkston commented that reserves may not be available as Cigarette Tax revenues have been declining.

a. Ohio County- Tara Henry

Tara reported Brett Glick and Paula Baldwin met with Ohio County Board. Communications from previous Chair and Auditor were not available. Tara noted the information would be available from prior meeting minutes. Tara is now working with Auditor to review AFR, as some issues could be with how expenses are labeled.

V. SSCB Board Reports and Discussion

a. SSCB Chairman's Report – Nola Gentry

Nola Gentry noted five Ivy Tech campuses have added Agriculture programs and are possibly adding Natural Resources to the two year programs. Gentry and Eddleman discussed Ivy Tech as a resource to the districts for training. This option would not take other staff member's time away from their duties. A review of the Business Plan is as follows:

Solidify Partnerships-Nola noted DNR and IDEM are getting more involved.

Meet with Top Leadership of ISDA and other agencies- Nola noted SSCB has met with Joe Kelsay on a variety of issues including funding, staffing and support.

Discussions with IDEM and ISDH on Septic issues- Nola noted this will be ongoing

Improve District Communication- SSCB will have a regional meeting in the spring. Nola also noted SharePoint will aid in communicating to districts.

Pursue Opportunities to meet with other State/Local governments-Mississippi River Basin Initiative has allowed ISDA to meet with other states.

a. Division of Soil Conservation Report

i. Technical Support Update – Jerod Chew

SharePoint data allows tracking of technical staff numbers

23 Resource Specialists are serving 51 counties, 236 individuals, 16,353 farm land acres, 390 practices, and 2,226 practice acres.

Leadership Institute- Board Development had 30 participants. Scott Hamm attended to discuss the business plan.

5 Star Score Card group met and discussed upcoming goals. Priority will be ensuring Districts do what they are required to do by law.

LI set for first week of December in Madison. Discussions will be on impacting the community. Warren Baird inquired about District accounting. SBA has notified at least one District that they are required to maintain physical ledgers, even if they are using QuickBooks. Nathan noted while QuickBooks has never been officially approved, it has been accepted in the past. Due to confusion, ISDA will contact SBA for clarification on this issue.
