- Where: Tri-North Middle School (Auditorium), 1000 W. 15th Street, Bloomington, IN 47404
- **Why:** The City of Bloomington has filed a petition before the Commission for a new schedule of rates and charges for water service.
- How: During field hearings, ratepayers have the opportunity to speak directly to the Commission or submit written comments. Please note, though, that because this is a pending case, the commissioners and judge are not allowed to answer questions or engage in any discussion about the case.
