## Indiana Utility Regulatory Commission



### Opportunity for Public Comment on Wastewater One's Rate Case

**What:** A field hearing will be held in Charlestown by the Indiana Utility Regulatory Commission (Commission) to hear from the public on the rate case petition, under Cause No. 44876, of Wastewater One (doing business as River's Edge Utility, Inc.).

**When:** March 28, 2017, at 6 p.m.

**Where:** Charlestown Senior High School, #1 Pirate Place, Charlestown, IN 47111

**Why:** Wastewater One has filed a petition before the Commission for a new schedule of rates and charges for water service.

**How:** During field hearings, ratepayers have the opportunity to speak directly to the Commission or submit written comments. Please note, though, that because this is a pending case, the commissioners and judge are not allowed to answer questions or engage in any discussion about the case.
