(2) The IURC approved alternative approaches to recover variances in Cause Nos. 43629 GCA 58 and 37389 GCA 126. The alternative approaches were approved in response to a severe cold weather event that occurred in February 2021 and created high natural gas supplier prices across the country. As such, the alternative variance recovery approach is included in the gas cost adjustment factors for Northern Indiana Public Service Co. (NIPSCO) and Citizens Gas of Westfield and will affect the gas costs for 12 and 24 months, respectively.
