Inc., d/b/a AdamsWells Telecom. This particular filing is for the AdamsWells CLEC. (As noted on Original Title Sheet 1 in the instant tariff, Craigville Telephone Co., Inc., d/b/a AdamsWells Telecom operates in Indiana as both an ILEC (incumbent local exchange carrier) and a CLEC (competitive local exchange carrier), under the same name. AdamsWells is currently operating as a CLEC in AT&T Indiana's Bluffton Exchange. The CLEC's *authorized* territory is the entire state of Indiana, but specifically excludes the ILEC's territory (i.e., the Craigville Exchange), as authorized by the Commission in Cause No. 44269 (Order issued on Nov. 3, 2004). As an ILEC, Craigville concurs

in the intrastate access tariff of West Point Telephone Co.)
