Pursuant to 170 IAC 4-7, Wabash Valley Power Association, Inc. d/b/a Wabash Valley Power Alliance ("Wabash Valley") submits to the Indiana Utility Regulatory Commission ("Commission") Wabash Valley's: (1) 2023 Integrated Resource Plan ("IRP") (redacted); (2) Technical Appendix (redacted) containing supporting documents; and (3) an IRP Executive Summary.
