Request: Citizens requests Commission approval to reduce its rates and charges for steam utility service, specifically for Rate 1, General Steam Service and Rate 2, Demand Rate Service.

In its Order from Cause No. 44781, issued November 22, 2016 (“44781 Order”), the Commission approved a settlement agreement among the Indiana Office of the Utility Consumer Counselor, Citizens Thermal Customer Group, and Citizens to include in its revenue requirement the amount of incentive payments made to Citizens’ customers during the test year for its low pressure steam optimization initiative. The Commission also approved the stipulation that if Citizens did not file a base rate case within four years of the issuance of its Order, Citizens would be required to adjust its rates to reflect the removal of the incentive payments via a thirty-day filing made to the Commission prior to the expiration of the four-year period following the issuance of the 44781 Order.

Citizens has elected not to file a base rate case by November 22, 2020 and therefore has made this submission to remove the incentive payments discussed above.
