ORDER OF THE COMMISSION

IT IS SO ORDERED.

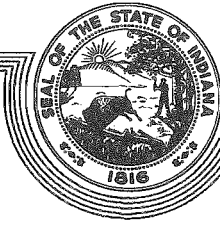
