**1. Ramsey Water Company, Inc.**



*The following new miscellaneous item has been reviewed by staff members of the Commission and we recommend accepting it for filing.*


**1. Ramsey Water Company, Inc.**

The utility is proposing to add monthly service and monthly minimum charges for six and eight inch meters. The establishment of these fees is necessary due to anticipation of future customers needing meters of this size. Currently, Ramsey does not have rates in place for meters of this size. Ramsey provided cost support for each of its proposed charges.
