The following Final Articles A and C are submitted to each of you to acquaint you with the tariffs eligible for action or acceptance on or after August 30, 2006.

"A" Final

The following new miscellaneous item will be eligible for final consideration at the next Commission Conference and based upon a review of it by staff members of the Commission, I recommend approval.

1. Sullivan Vigo Rural Water Corporation

The utility is proposing to increase the connection (tap-on) charge for a 5/8 inch meter from \$695.00 to \$775.00. The reason for this increase is due to increases in labor and material costs. The tap-on charge for a meter larger than 5/8" shall be the actual cost of materials and installing the tap, but shall not be less than the charge of a 5/8" meter tap. If a road bore is necessary to complete the tap, the charge will be \$714.00 in addition to the \$775.00 tap charge totaling \$1,489.00. The utility also proposes to add renters to the Membership Fee charge. Cost support has been provided for the changes to the connection charges.


