Request: This 30-Day Filing establishes a new intrastate tariff (TARIFF I.U.R.C. No. 2) to clarify which parts of the IURC T-7 tariff each company concurs in. The **ILEC** concurs in the following sections of the T-7 tariff: Explanation of Symbols; Part I Section I (Indiana Universal Service Fund Surcharge (“IUSF”)); Part II Section II (Low Income Programs (“Lifeline”)); and Part III, Section III (Dual Party Relay Services Surcharge (“InTRAC”)). The **CLEC** concurs in all of the above tariff sections, *except* for Lifeline (Part II Section II.)

Retail Customer Impact: No additional impact on customers, other than to memorialize, through the establishment of Tarff I.U.R.C. No. 2, certain surcharges or credits that the Indiana General Assembly, the IURC, and/or the FCC has already authorized.

Tariff Page(s) Affected: Tariff I.U.R.C. No. 2, Original Page 1.

Staff Recommendations: Requirements in 170 IAC 1-6 were met, including 170 IAC 1-6-3(2).
Recommend APPROVAL.

¹ The ILEC and CLEC operate under the same name: Washington County Rural Telephone Cooperative, Inc. d/b/a Tele-Media Solutions. The CLEC is authorized to provide various communications services throughout the state of Indiana, except in the ILEC’s local exchange service territory.
