

**ANNUAL REPORT OF THE INDIANA PUBLIC ACCESS COUNSELOR
To the Indiana General Assembly**

July 1, 2008 through June 30, 2009

Pursuant to Ind. Code § 5-14-4-12, the Indiana Public Access Counselor (“PAC”) hereby submits this annual report of activities for the time period covering July 1, 2008 through June 30, 2009.¹ This report is presented in three parts: in Part I a narrative summary of the activities of the PAC; in Part II the information required to be submitted pursuant to I.C. § 5-14-4-12; and in Part III appendices listing presentations given and advisory opinions issued in the past year.

**PART I
Annual Report Narrative**

Public Access Counselor and Staff

On July 1, 2007, Governor Daniels appointed Public Access Counselor Heather Willis Neal to a four-year term of office ending June 30, 2011. The PAC also employs one full-time administrative assistant. During FY09, the counselor took a maternity leave. During the leave, the counselor continued to issue written advisory and informal opinions.

Advisory Opinions

From July 1, 2008 to June 30, 2009, the PAC issued 226 written advisory opinions in response to formal complaints. *See* I.C. 5-14-5 regarding the complaint process. Seven complaints were pending as of June 30, 2009. Pursuant to I.C. § 5-14-5-9, an advisory opinion must be issued within thirty days of receipt of a formal complaint. The deadline for priority complaints is seven days. I.C. § 5-14-5-10; 62 IAC 1. The PAC met the statutory requirement for timely issuance of advisory opinions. A detailed list of advisory opinions follows in Appendix B.

Informal Opinions

In addition to advisory opinions in response to formal complaints, the PAC issues written informal opinions in response to written informal inquiries. Upon taking office on July 1, 2007, the current PAC found a backlog of requests for informal opinions, with some of those requests dating back to 2005. As of February 8, 2008, the current PAC and assistant cleared that backlog. The established turn-around time for those informal opinions is now approximately three weeks. The PAC issued 47 informal opinions for the period July 1, 2008 to June 30, 2009. For the third and fourth quarters of 2008, the PAC maintained an average turn-around time of approximately fifteen and eleven days, respectively. For the first and second quarters of 2009, which were affected by the counselor’s maternity leave, the PAC maintained an average turn-around time of 42 and 28 days, respectively.

Telephone and Electronic Mail Inquiries

From July 1, 2008 to June 30, 2009, the two PAC staff members received and responded to 2,270 inquiries via telephone and electronic mail.

Education and Presentations

The Public Access Counselor made twenty educational presentations in nine different Indiana cities and towns over the past year. Appendix A contains a list of the presentations.

Handbook and Other Educational Materials

The *Public Access Handbook* was not revised in 2009 because no enacted amendments were made to the Access to Public Records Act (I.C. 5-14-3) or the Open Door Law (I.C. 5-14-1.5). The *Handbook* is a resource utilized by many public officials and the public at large, and the PAC receives many requests for the print version of the *Handbook*. The *Handbook* is posted on the PAC's website, www.IN.gov/pac, and the PAC encourages individuals and agencies to download it from the website at no charge. While there is still strong demand for a paper version of the *Handbook*, the PAC budget does not allow printing of bound copies of the *Handbook* (the PAC will, of course, print a copy pursuant to a request for access to records and charge the requester \$.10 per page for the copy). In FY08, the Indiana Coalition for Open Government ("ICOG"), through a grant from the National Freedom of Information Coalition, and the Hoosier State Press Association ("HSPA") printed copies of the *Handbook*. On June 25, 2008 the PAC received 525 copies of the *Handbook* for distribution to individuals and agencies; all costs for the handbooks received by the PAC were paid by the ICOG grant and the HSPA. The PAC has distributed all printed copies of the *Handbook*.

In addition to the *Handbook*, the PAC has continued to create new resources and make those available via the PAC website. The Counselor also prepared slides and handouts for participants at the educational seminars to which the Counselor was invited. Because the PAC budget will not allow the PAC to provide copies of slides and handouts to attendees at all events (some of which number in the hundreds), the PAC generally asks the sponsoring organization to provide copies for attendees. The PAC makes copies of all slide presentations available via the PAC website.

Public Access Counselor Website

The Office of the Public Access Counselor maintains a website at www.in.gov/pac. The website contains more than 1,700 formal advisory opinions issued since 1998. In addition to the resources listed in previous paragraphs, the website contains select informal inquiry responses, upcoming and past presentations of the Public Access Counselor, sample letters and meeting notices, frequently asked questions and other resources.

Oversight Committee on Public Records

Pursuant to I.C. § 5-15-5.1-18, the Public Access Counselor serves as a member of the Oversight Committee on Public Records, the governing body for the Indiana Commission on Public Records. The counselor was recently elected Chair of the Oversight Committee.

The number of complaints does not match the number of advisory opinions issued because some complaints were withdrawn or consolidated with other complaints before the PAC issued an opinion.
