## PART II Executive Summary

#### **Advisory Opinions**

Since July 1, 2002, the Office has issued 91 written advisory opinions. Eight (8) opinions are pending as of this report. Under Indiana Code sections 5-14-5-9 and 10, advisory opinions must be issued within either seven (7) or thirty (30) days of receipt by the Office. A more detailed listing of these opinions and a brief description of the opinions follow in Appendix B, below.

#### **Education and Presentations**

Twenty-seven (27) educational presentations were held for various groups over the past year. A full listing of these presentations follows in Appendix A, below.

#### Access Handbook and other Educational Materials

The Public Access Handbook was most recently revised effective November 2002 and it is posted on the Office's website, <a href="www.state.in.us/pac">www.state.in.us/pac</a>. We distribute the printed copies of the Handbooks during the educational presentations mentioned in the previous section of this Part and directly to citizens and public offices.

#### Oversight Committee on Public Records

Effective July 1, 2001, the Public Access Counselor serves as a member of the Oversight Committee on Public Records, the governing body for the Indiana Commission on Public Records. The Committee generally meets one time each month. During the past year, Anne Mullin O'Connor assisted with the adoption of the administrative rules to update the microfilming standards administrative rule, 60 IAC 2 and served as Chair of the Committee in 2003.
