

**ANNUAL REPORT OF THE PUBLIC ACCESS COUNSELOR
To the Indiana General Assembly**

July 1, 2005 through June 30, 2006

PART II

Executive Summary

Public Access Counselor and Staff

The Office of the Public Access Counselor is staffed by Karen Davis, the Public Access Counselor, and one administrative assistant. Karen Davis was appointed to fill a four-year term of office ending June 30, 2007.

The Office of the Public Access Counselor employed staff attorney April Schultheis until March 14, 2006. The Public Access Counselor then determined that an administrative assistant was needed. The staff attorney position was converted to a Pat II level Administrative Assistant.

Advisory Opinions

From July 1, 2005 to June 30, 2006, the Office issued 219 written advisory opinions. Eighteen complaints were pending written advisory opinions as of June 30, 2006. Under Indiana Code 5-14-5-9 and 10, advisory opinions must be issued within either seven (7) or thirty (30) days of receipt of a formal complaint. The deadline for priority complaints is seven days (62 IAC 1). The Office met the statutory requirement for timely issuance of advisory opinions. A detailed list of advisory opinions and a brief description of the opinions follow in Appendix B, below.

Education and Presentations

The Public Access Counselor made thirty-two educational presentations for various groups over the past year. This was a decrease of two presentations over the previous reporting period. Notably, the Public Access Counselor traveled to Boston to participate in a panel at the Council on Governmental Ethics Laws Annual Conference (COGEL) on December 5, 2005. In addition, the Public Access Counselor participated in two panels at the Federal Freedom of Information Summit held in Indianapolis in April, 2006.

Handbook and Other Educational Materials

The Public Access Handbook was most recently revised in December 2003, and it is posted on the Office's website, www.IN.gov/pac. The Office plans to update the statutes in the Handbook to reflect legislative changes in the access laws enacted in 2005 and 2006. The Office receives many requests for the print version of the Handbook. As of this report, the Office's supply of paper handbooks has been nearly depleted. In order to save cost to the Office, the Office encourages persons to download the Handbook from the web for free. However, there is still strong demand for a paper Handbook, even where the requesters have access to the electronic version.

Public Access Counselor Website

The Office of the Public Access Counselor maintains a website at www.in.gov/pac. In March 2006, the Public Access Counselor added new content to the website. Included in the

improved website are select informal inquiry responses (www.in.gov/pac/informal), upcoming presentations of the Public Access Counselor (www.in.gov/pac/presentations), and Frequently Asked Questions (www.in.gov/pac/faq). The Public Access Counselor intends to make more improvements to the website in 2006-07.

Oversight Committee on Public Records

Pursuant to Indiana Code 5-15-5.1-18, the Public Access Counselor serves as a member of the Oversight Committee on Public Records, the governing body for the Indiana Commission on Public Records. The Committee generally meets one time each month.
