The Attorney General's Office provided the Board with a report per IC 25-1-7-13. Ian Matthew, Deputy Attorney General, presented the report to the Board and explained the role of the Attorney General's Office to the new Board members.

Re: Default Hearing

Respondent did not appear for their default hearing. Deputy Attorney General (DAG) Ian Mathew appeared for the State.

A motion was made by Member Skeen and seconded by Member Schenkel to grant the State's motion to default Respondent.

DAG Ian Mathew stated this matter was due to failure to omit records and was connected to Andrew Hamaker (suspended renewal fraud in 2022). The criminal case was dated March 2022 and Hamaker potentially committed theft of over \$50k. The case is still pending. He potentially embezzled from the royal order of the jesters by issuing checks from the organization to himself and his entities such as Pathfinder CPA.

Andrea Mills appeared as the State's witness. Ms. Mills is a licensing enforcement investigator that investigates consumer complaints and has reviewed this file. State's exhibit A was the first consumer complaint received and State's exhibit B was the second consumer complaint received. Both were admitted into evidence. State's exhibit c was Andrew Hamaker's Final Order and was admitted into evidence. State's exhibit D was the criminal documentation and State's Exhibit E was the probable cause affidavit and both were admitted into evidence. There are 3 total counts. DAG Ian Mathew recommends a civil penalty and suspension with violation of all counts.

A motion was made by Member Skeen and seconded by Member Wright to find Respondent in violation of the Statutes within Counts 1, 2, and 3. 4-0-0, Motion carried.

PROC Annual Report

Alan Parks and Jason Raver appeared and presented the annual report for the Peer Review Oversight Committee. PROC has had two meetings so far this year. Each Committee in each State is different with reporting. The number of firms enrolled in Indiana was 199 this year and last year it was 284. There were 73 peer reviews conducted this year and last year there were 100. There were 43 system reviews this year and 54 last year. There were 30 engagement reviews this year and 47 last year. There were 2 failed system reviews, and 3 failed engagement reviews this year. PROC members sat in on RAB meetings this year to better understand the peer review process with the Illinois CPA Society.

Investigative Fund Statement

Member Barton explained the purpose of the investigative fund and reviewing the statement. The Board reviewed the investigative fund statement.

Compliance Officer Report

The compliance officer attended NASBA's annual virtual meeting from October 30th- November 1st. One of the hot topics was over AI and its ethical and practical uses (auditing and confidentiality). Model Rule Amendments for peer review were also discussed that could affect the Board's peer review rules. The compliance officer will email the Board members the meeting's packet of information. Otherwise loose ends are being wrapped up in preparation for next year's renewal and audit season.
