DISCUSSION ITEMS

The board discussed the reinstatement of John Cordogan. They determined that he was missing two CEUs and denied his request for reinstatement.

Charles Bridenthal – the board discussed the CE he submitted, which was determined unacceptable CE due to the fact that it is simply discussion/research with another individual about a project and not a course of any kind and did not state whether they were HSW or not.

The board discussed the renewal of Elizabeth Heiny-Cogswell and determined that her license must be renewed, but that due to her not having sent CE that was requested, the board ordered to send her a notice of non-compliance and fine her \$1000.

The board discussed the renewal of Edward Garrett. They determined that his license renewal request should be denied because he indicated on his renewal application that he had completed the required CE and wrote a letter to the board indicating that he had not done so.


Ohio Revisions to Sealing Process –should we proceed with investigating whether Indiana should follow the new process Ohio has, signature, license number and expiration date. The board would like to pursue this in the submission of a rule.

Expired Registrations and License Probation - The board discussed the issue of paying to renew an inactive license and may seek to eliminate the fee for renewing to inactive status.


