NCARB Regional Meeting David Rausch attended the regional meeting last week. The President of NCARB has on his agenda to visit all member boards during his tenure. NCARB is



Indiana State Department of Health- Richard Fetz, Donna Sembroski, and Crystal Heard met with representatives from the Department of Health to discuss having an architect certify food serving drawings for nursing homes. ISDH have requirements the documents need to be certified. However, architects are not supervising these plans. Have kitchen equipment planner certify documents. Or have the architect certify documents as just placement of where the equipment is going. Discuss with ISDH to write a guideline that the board will help write and disseminate to professionals.
