*WHEREAS*, under Indiana Code 36-2-3-4(b), the Lake County Redistricting Commission is required to divide Lake County into seven (7) single member county council districts during 2021; and

*WHEREAS*, at its October 29, 2021 meeting, the Lake County Redistricting Commission (hereafter "the Commission") adopted procedures and deadlines to perform its duties under these statutes; and

*WHEREAS*, pursuant to these procedures, three proposed plans to establish county council districts were submitted to the Indiana Election Division before noon EST, November 29, 2021, these plans being designated by the Commission as "Plan #3", "Plan #5", and "Plan #6"; and

*WHEREAS*, pursuant to these procedures, the Commission conducted a public hearing in Lake County on December 10, 2021 to receive testimony from any interested person regarding the proposed plans, and the redistricting process; and

*WHEREAS*, the Commission finds that the proposed county council districts described in "Plan #6", as modified in this Order, best comply with the requirements for establishing districts under both federal law, including equal representation under the Constitutional requirement of "one person, one vote" and state law, including Indiana Code IC 36-2-3-4;

**NOW, THEREFORE, BE IT ORDERED BY THE LAKE COUNTY REDISTRICTING COMMISSION:**

**SECTION 1.** Lake County is divided into the seven (7) single-member county council districts set forth in the document designated by the Commission as "Plan #6 County Council Districts", as amended at the December 17, 2021 meeting. This Plan is amended as described in Exhibit #1 that is attached to this Order and incorporated by reference.

**SECTION 2.** The following documents are incorporated by reference into this Order:

- (1) The minutes of the October 29, 2021 meeting of the Commission, including the documents incorporated by reference in those minutes.
- (2) The sets of documents designated as "Plan #3", "Plan #5", and "Plan #6" by the Commission at its December 10, 2021 meeting.
- (3) The maps and other documents entered into the record of the December 10, 2021 meeting or December 17, 2021 meeting.

**SECTION 3.** As required by IC 36-2-3-4, this division is ordered during the first year after the year in which the most recent federal decennial census was conducted (2021).

**SECTION 4.** Effective January 1, 2022, all previous Orders adopted by the Commission concerning County Council Districts are rescinded.

**SECTION 5.** Notwithstanding SECTION 4, as provided by Indiana Code 36-1-6-10(b), any rescinded or expired orders establishing county council districts remain in effect for the limited purpose of filling any vacancy that may occur among the membership of the County Council of Lake County during the period ending with the expiration of that member's current term for that office.

**SECTION 6.** As provided in Indiana Code 36-1-6-10(d), the adoption of this Order has no effect on the right of an individual serving as a member of the County Council of Lake County to continue to serve in that office until the expiration of the member's current term specified under state law.

**SECTION 7.** The Election Division shall provide a copy of this Order to the County Council of Lake County and to the Lake County Board of Elections and Registration.

**SECTION 8.** The Election Division shall, as soon as practicable, produce an electronic map of boundaries of the county council districts described in Section 1 of this Order and file a copy of the electronic map with the Lake County Circuit Court Clerk and the Lake County Board of Elections and Registration.
