12. Name any malfunctions or problems with voting system during election.

- A. In Barr 2 Precinct one of the two machines for voting was tallied out with 0 votes before it was even enabled for voting, which made that machine unavailable for voting on May 2, 2006. The poll workers did not follow their step-by-step instructions for preparing the machine for voting. It was predicted to be a slow day in that precinct. They had been given an extra machine for handicapped accessibility. The machine was picked up by curriers and brought back to Daviess County Courthouse. The precinct poll workers were instructed on how to use the remaining machine for accessibility for handicapped voters.**
- B. On Monday, May 8, 2006, Keith Ellis, a Caucasian English speaking man, came to the Courthouse to report that on May 2, 2006 at about 5:50 P.M. he went to vote at the West End Fire Station, Washington Precinct 10, to vote. He used the Spanish version of the ballot on the Republican ticket. He reported that two of the candidates' buttons did not work on the ballot. He said that he brought it to the attention of the poll workers, who told him that it didn't really matter, as the candidates were unopposed on the ballot. Neither the Inspector, nor any other person, called the Clerk or the Voter Registration Office to report this. If they had, they would have been instructed to cancel the vote before it was submitted, and to vote on the English version of the ballot, which is the voter's native language. I reported this incident to MicroVote Corporation, suggesting a more thorough check of ballot buttons, and requesting more training for Clerk's staff in regard to the machines. The Clerk will be more watchful of the machine mechanisms in the General Election, and will stress to the Inspector's in training that this is the type of incident to report to the Clerk as it occurs.**
