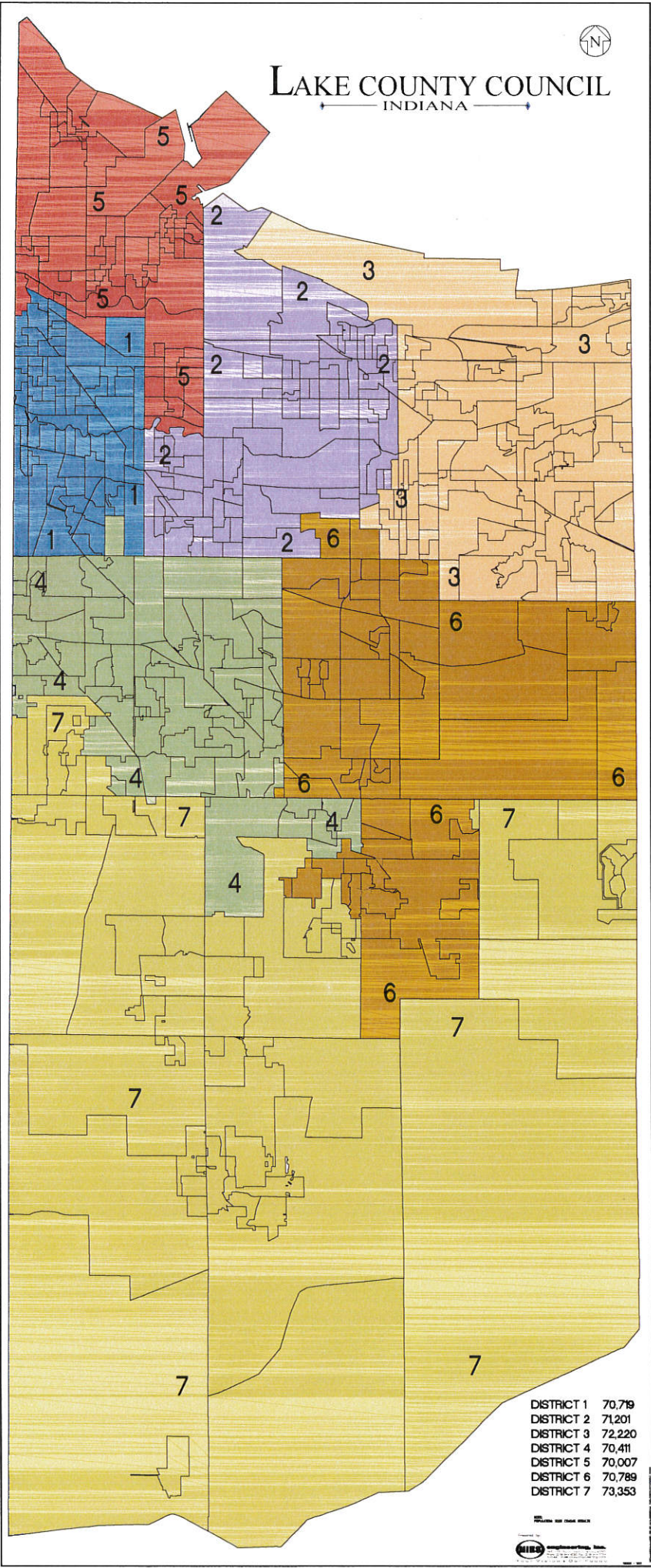

**RE: Lake County Council Proposed District Maps**

Dear Chairman Okeson,

Pursuant to Order No. 2021-1 of the Lake County Redistricting Commission, attached please find a proposed redistricting map submitted on behalf of the Lake County Democratic Central Committee, by myself as Chairman. Accompanying the proposed map is census population data as also required by Order No. 2021-1 dated October 29<sup>th</sup>, 2021.

In preparation of the proposed map, we were cognizant of, and guided by, all statutory requirements relative to redistricting, including staying well within the 10% acceptable margin. Most importantly, in Lake County we were guided overall by the conclusions of the 2020 census and the recognition of the population change since the date of the last census. We believe that the proposed map is clearly consistent with these guidelines.

Should you have any questions relative to the submission, or any part thereof, please do not hesitate to contact me. We look forward to the public hearing forthcoming in Lake County on December 10<sup>th</sup>.
