#### **MINUTES**

#### ALCOHOL AND TOBACCO COMMISSION

#### JANUARY 17, 2024

### CALL TO ORDER/NOTING OF QUORUM

Chair Allen called the meeting to order and noted the quorum and the attendance. Vice Chairman Payne, Commissioner Maginn, Commissioner Jones, General Counsel Merritt, Prosecutor Wignall, and Deputy Director Chris Serak were in attendance.

#### **DISPOSITION OF MINUTES**

Vice Chairman Payne moved to approve the minutes from the January 3, 2024 meeting. Commissioner Jones seconded. The motion was unanimously approved.

#### PROSECUTOR'S RECOMMENDATIONS

<u>PARTIES' AGREED DISPOSITIONS</u> — Vice Chairman Payne moved to approve the Parties' Agreed Dispositions, submitted by Prosecutor Wignall. Fifty-three dispositions were submitted with fines totaling \$56,900.00. Commissioner Jones seconded. The motion was unanimously approved.

#### HEARING JUDGE'S RECOMMENDATIONS

<u>DL8232241 BT MARKET INCORPORATED</u> – Vice Chairman Payne stated the permittee has pending violations for sale of cold beer and sale of tobacco without certificate. Notices were sent and the permittee failed to appear for the settlement conference and the show cause hearing.

Vice Chairman Payne moved to revoke the permit. Commissioner Jones seconded. The motion was unanimously approved.

<u>BR1492582 MICHAEL MALKOWSKI</u> - Vice Chairman Payne stated this permittee has a violation for receiving two OWI convictions and those convictions, currently, make him ineligible to hold a permit. The permittee failed to appear at the settlement conference and the show cause hearing for this violation.

Vice Chairman Payne moved to revoke the employee permit. Commissioner Jones seconded. The motion was unanimously approved.

<u>BR1905596 MORGAN CHARLES</u> - Vice Chairman Payne stated this permittee has a violation for receiving two OWI convictions and those convictions, currently, make her ineligible to hold a permit. The permittee failed to appear at the settlement conference and the show cause hearing for this violation.

Vice Chairman Payne moved to revoke the employee permit. Commissioner Maginn seconded. The motion was unanimously approved.

<u>BR1893381 BRYANT TAYLOR</u> - Vice Chairman Payne stated this permittee has a violation for receiving two OWI convictions and those convictions, currently, make him ineligible to hold a permit. The permittee failed to appear at the settlement conference and the show cause hearing for this violation.

Vice Chairman Payne moved to revoke the employee permit. Commissioner Jones seconded. The motion was unanimously approved.

<u>BR1596250 GINA NEGRELLI</u> - Vice Chairman Payne stated this permittee has a violation for receiving two OWI convictions and those convictions, currently, make her ineligible to hold a permit. The permittee failed to appear at the settlement conference and the show cause hearing for this violation.

Vice Chairman Payne moved to revoke the employee permit. Commissioner Jones seconded. The motion was unanimously approved.

#### CONSIDERATION OF APPLICATIONS

Commissioner Jones moved to approve and incorporate by reference these lists of permits for renewal, which have been recommended by local boards and reviewed by said staff with the authority of the Commission, and hereby move for approval of same, pending any escrow hearings, and the inclusion of these lists as part of the minutes. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve and incorporate by reference these lists of permit applications for a new permit or application for changes in location, ownership, or both of existing permits, which have been recommended by local boards and reviewed by at least two Commissioners and hereby move for approval of same, pending final floor plan approval by the Indiana State Excise Police and escrow, if needed, and inclusion of these lists as part of the minutes. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the catering applications. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the carrier applications. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the direct wine seller applications. Commissioner Maginn seconded. The motion was unanimously approved.

#### WAIVERS OF FEES – LETTERS OF EXTENSION

Vice Chairman Payne moved to approve the fee waived letters of extension issued the preceding weeks. Commissioner Maginn seconded. The motion was unanimously approved.

#### **ITEMS FOR DISCUSSION**

<u>RR0240772 HAYLOFT CATERING LLC</u> - Chair Allen noted this is a request for catering hall designation.

Commissioner Maginn moved to approve the request for catering hall designation. Vice Chairman Payne seconded. The motion was unanimously approved.

<u>RR4937158 VEGAS HOOKAH LOUNGE & BAR LLC</u> – Chair Allen noted this is a transfer with the local board voting 4-0 to deny.

Commissioner Maginn stated there were several remonstrators at the hearing. There were problems at the previous location such as fights, vandalism, disorderly conduct, and public intoxication. The applicant has another location in Lawrence where there have also been problems with police runs.

Commissioner Maginn moved to uphold the local board's recommendation to deny the transfer. Commissioner Jones seconded. The motion was unanimously approved.

RR4938969 GPX, LLC - Chair Allen noted this is a renewal with the local board voting 2-1 to approve.

Commissioner Maginn stated there was discussion at the hearing regarding false ownership. This involves a husband and wife. The wife being the only one listed as owner, but the perception is that the husband is running the business. The establishment was sold in November and the permittee would like to transfer the permit.

Commissioner Maginn moved to uphold the local board's recommendation to approve the renewal, only for the purposes of transfer. Commissioner Jones seconded. The motion was unanimously approved.

Chair Allen asked that an Escrow Request be filed in this matter.

<u>RR2937928 CROWN NAILS SALON LLC</u> – Chair Allen noted this is a renewal with the local board voting 3-0 to deny.

Commissioner Maginn stated this establishment has been cited for several violations.

Commissioner Maginn moved to uphold the local board's recommendation to deny. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR9137972 JOSE MIRANDA AYALA, LLC</u> – Chair Allen noted this is a transfer with the local board voting 4-0 to deny.

Commissioner Maginn stated the applicant was convicted of a class C misdemeanor, not related to alcohol.

Commissioner Maginn moved to overturn the local board's recommendation and approve the transfer. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones noted that if the applicant gets any more traffic violations, he may vote differently in the future.

## RR2938865; RR2938748; RR2938747 WATSON HOLDINGS INC -

Chair Allen

These were continued from the December 19, 2023 meeting. These permits ae held by Watson Holdings Inc., which is 100% owned by Peter Watson. They've previously been before the commission on a violation matter related to falsification of records that tied back to whether there was a lease interest in the permit premises. Permittee admitted those violations and settled that matter with a fine. The commission, while handling an extension request, ordered that the permits be placed in escrow and backdated the escrow start date to the original issuance date since the alcoholic beverage permits were never truly active. When the matter came before the Hamilton County local alcoholic beverage board, the permittee was required to appear due to the Hamilton County Local Board denied the three permits on November 14, 2023. Following the commission meeting on November 21st, the commission requested additional information related to the leases and franchise agreements that the permittee was relying on to demonstrate the right to own or possess the permit premises. That information was provided prior to December 19th, but was lengthy and so at that point, the commission voted to continue the matter to today's date to be allowed to further review the documentation. I did review the documentation that was provided. First, I will ask that the record supplied to the commission be maintained confidential to the extent that the terms of the leases or franchise agreements contain proprietary or otherwise confidential information. The extent of the discussion today will be about whether the terms of the contracts, agreements or leases give Watson Holdings, Inc. a lease interest in the permit premises but not any of the further terms of the franchise agreement. What I found when I reviewed it was that the franchise agreements relied on by Watson Holdings Inc. are between the franchisee and Hot Box Pizza Franchising LLC. The terms of the franchise agreement include a provision in which at the franchisor, or Hot Box Pizza Franchising LLC, at the franchisor's option, the franchisor may require a provision in a lease reserving to the franchisor, the right, but not the obligation, to receive an assignment of a leasehold interest. Two of the three requested leases were provided. Those two leases were assignments of a lease from a prior franchisee to the current franchisee. But Hot Box Pizza Franchising LLC and Watson Holdings Inc. were not parties to that. They were entered into between the landlord and the tenant. The terms of the lease agreement specifically state, "tenant will not assign nor sublet this lease in whole or in part, nor permit any change in use of the leased premises without the written consent of the owner." We did not receive a copy of the lease, or I did not have one for the Carmel location. So, it seems like they had the option to put that in the lease but they did not exercise it on the front end so I don't see that now they can claim to have that right in a lease that specifically says it cannot be sublet or assigned. So, and then with that I didn't even reach the analysis of whether Watson Holdings LLC could step in for Hot Box Pizza Franchising LLC in this situation. So, with that, I would move to uphold the denial of the Hamilton County Local Board.

Chair Allen It's been moved and seconded. Any further discussion?

Commissioner Jones Not on my part.

Chair Allen Okay. All those in favor indicate by saying, aye.

Vice Chairman Payne Aye.

Commissioner Maginn Aye.

Commissioner Jones Aye.

Chair Allen Opposed say, no. Motion carries.

<u>DL2930771 INDY GO GAS AND CONVENIENCE LLC</u> – Chair Allen stated the local board and Commission denied the renewal for failure to appear at the local board hearing as required due to violations in the renewal period. An appeal was filed. The Chair recommended the Commission allow one more opportunity for the permittee to appear before the local board.

Commissioner Jones moved to remand the renewal to the local board. Commissioner Maginn seconded. The motion was unanimously approved.

RR8200285 AMY'S LAMASCO BAR LLC - Chair Allen noted this is a request for extension.

Commissioner Maginn stated the renewal was denied and the permittee requested the ability to file a transfer. The transfer is scheduled for local board on February 13, 2024. This is the 3<sup>rd</sup> request for escrow.

Commissioner Maginn moved to approve a 30-day extension. Commissioner Jones seconded. Chair Allen approved. Vice Chairman Payne voted to deny the motion. The Vice Chairman stated this has been an issue for quite some time and a newspaper article was provided showing the bar would close on January 15<sup>th</sup>. He sees no reason to grant a 3<sup>rd</sup> extension. By the 2<sup>nd</sup> extension he feels matters should be taken care of with no need for an additional extension. The motion was approved 3-1.

DL7130601 HOOK-SUPERX LLC – Chair Allen noted this is a request for extension.

Commissioner Maginn stated there was an issue with scheduling the local board for this renewal.

Commissioner Maginn moved to approve a fee-waived 90-day extension. Commissioner Jones seconded. The motion was unanimously approved.

RR8235106 WORDOM INC. – Chair Allen noted this is a request for extension.

Commissioner Maginn stated the local board for renewal of this permit did not have a quorum and had to be continued.

Commissioner Maginn moved to approve a fee-waived 90-day extension. Commissioner Jones seconded. The motion was unanimously approved.

RR1222698 EL JARIPEO #5 LLC – Chair Allen noted this is a request for extension.

Commissioner Maginn stated there was a processing error regarding this renewal.

Commissioner Maginn moved to approve a fee-waived, 90-day extension. Commissioner Jones seconded. The motion was unanimously approved.

RR5536667 BRL PROPERTIES LLC--Chair Allen removed this item from the agenda.

<u>RR3404922 DM MANAGEMENT INC.</u> – Chair Allen stated this was added by consent for an extension request.

Commissioner Maginn stated the renewal was continued by the local board for failure to appear as required because of a violation.

Commissioner Maginn moved to approve a 90-day extension. Vice Chairman Payne seconded. The motion was unanimously approved.

## Noteworthy Violations for 1/17/24 Commission Meeting

<u>DL4504813</u>: Economy Package Liquors #3 Inc. (DBA: Economy Package Liquors) in Gary, Lake County. In January 2022, this long-term investigation began as an anonymous complaint that Economy Liquors was shipping alcohol beverages and tobacco products to liquor stores in Illinois and Michigan. The complaint was assigned to Officer Brant Mendenhall for further investigation. After researching the business' permit, its history and limitations, Off. Mendenhall installed a camera on a public utility pole near the location. This camera provided 24/7 live video footage of the business. Between April 5, 2022 and June 29, 2022, video evidence and surveillance from officers confirmed the original complaint. On June 29, 2022, Officers served a search warrant at the business, which provided additional paper and electronic evidence. Following a full analysis of all evidence, it was determined that the business was illegally selling alcoholic beverages to other retail stores without a wholesale permit. Violations were written for Scope of Liquor Dealer's Permit, Credit Sales, Dealing Unauthorized Beverages, Sale or Receipt from Non-permittee, Sale & Possession of Adulterated or Misbranded Beverages, Falsification of Recors, and various employee permit violations. The parties have agreed to a \$25,000 civil penalty, a 30-day suspension, and the business will be placed on the PACE program.

RR4534043: MARS Properties Management Inc. (DBA: Draft House) in Lake Station, Lake County. In the summer of 2023, District 1 Excise Officers received a complaint from the Lake Station Police Department that the business had numerous fights and other criminal activity. Officer Kaycee Sullivan investigated the complaint and found reports of investigations for batteries, DUIs, narcotics, and criminal recklessness/mischief that doubled any other permitted premise in the area. A violation was written for public nuisance. The location was placed on the PACE program in August 2023. The parties have agreed to a \$1,000 civil penalty and a 3-day suspension.

TC16313001: The Rain Smoke Shop LLC in Greencastle, Putnam County. On December 22, 2023, District 3 Officers Alex Vargo and Robert Miller conducted an investigation at the business. During this investigation, Officers observed four underage subjects enter the business and one of them purchased a vape device. It was confirmed that the subjects were not asked for identification by the on-duty employee. The business has prior violations for sales to a minor. The parties have agreed to a \$1,000 civil penalty and a 3-day suspension.

<u>TC16074001</u>: Aurora Retail Inc. (DBA: VIP Smoke Shop) in Aurora, Dearborn County. On September 16, 2023, District 4 Officers Thomas Tully and Steven Stepleton conducted a tobacco compliance check at the location. During this check, the on-duty clerk sold a vape device to a 20-year-old youth without asking for his identification, date of birth, or age. A violation was written for sales to a minor and allowing a minor in a tobacco shop. The business has prior violations for sales to a minor. **The parties have agreed to a \$1,000 civil penalty and a 3-day suspension.**
