ALCOHOL AND TOBACCO COMMISSION

DECEMBER 19, 2023

CALL TO ORDER/NOTING OF QUORUM

Chair Allen called the meeting to order and noted the quorum and the attendance. Vice Chairman Payne, Commissioner Maginn, Commissioner Jones, General Counsel Merritt, Prosecutor Wignall, and Deputy Director Chris Serak were in attendance.

INTRODUCTION OF COMMISSIONER MARK A. JONES – Chair Allen introduced and welcomed Commissioner Mark A. Jones to the Commission. Mark is taking the place previously held by Dale Grubb.

DISPOSITION OF MINUTES

Vice Chairman Payne moved to approve the minutes from the December 5, 2023 meeting. Commissioner Maginn seconded. The motion was unanimously approved.

PROSECUTOR'S RECOMMENDATIONS

PARTIES' AGREED DISPOSITIONS – Vice Chairman Payne moved to approve the Parties' Agreed Dispositions, submitted by Prosecutor Wignall. Twenty-seven dispositions were submitted with fines totaling \$16,700.00. Commissioner Jones seconded. The motion was unanimously approved.

HEARING JUDGE'S RECOMMENDATIONS

No Hearing Judge's Recommendations

CONSIDERATION OF APPLICATIONS

Commissioner Jones moved to approve and incorporate by reference these lists of permits for renewal, which have been recommended by local boards and reviewed by said staff with the authority of the Commission, and hereby move for approval of same, pending any escrow hearings, and the inclusion of these lists as part of the minutes. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve and incorporate by reference these lists of permit applications for a new permit or application for changes in location, ownership, or both of existing permits, which have been recommended by local boards and reviewed by at least two Commissioners and hereby move for approval of same, pending final floor plan approval by the Indiana State Excise Police and escrow, if needed, and inclusion of these lists as part of the minutes. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the catering applications. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the carrier applications. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the direct wine seller applications. Commissioner Maginn seconded. The motion was unanimously approved.

By consent, the Commission added permit #ELM1800063 and permit #ELM1800061 to the agenda for approval.

Commissioner Jones moved to approve the e-liquid permit applications. Commissioner Maginn seconded. The motion was unanimously approved.

WAIVERS OF FEES – LETTERS OF EXTENSION

Vice Chairman Payne moved to approve the fee waived letters of extension issued the preceding weeks. Commissioner Maginn seconded. The motion was unanimously approved.

ITEMS FOR DISCUSSION

RR3438183 SIMS ENTERTAINMENT GROUP, LLC – Chair Allen noted this permit was made dead at the December 5, 2023 meeting. Permittee requested the permit be removed from the dead list and allowed to file a transfer, but the request was mistakenly overlooked at the last meeting.

Commissioner Maginn stated an escrow request was submitted stating there was a buyer for the permit. There is also a tax protest on the permit.

Commissioner Maginn moved to set this for the January 3, 2024 meeting to rescind the vote making the permit dead and to reactivate it for transfer purposes, conditioned on the tax protest being cleared. Commissioner Jones seconded. The motion was unanimously approved.

DL4933409 SSD OIL INC. – Chair Allen noted the local board asked for this transfer to be remanded.

Commissioner Maginn stated the local board was notified after their hearing that the notice to neighbors was not sent timely.

Commissioner Maginn moved to remand the transfer to the local board. Commissioner Jones seconded. The motion was unanimously approved.

RR4940329 MASS AVE NUTRITION LLC – Chair Allen noted this is a new application with the local board voting 4-0 to deny for failure to appear.

Commissioner Maginn moved to uphold the local board's recommendation to deny. Commissioner Jones seconded. The motion was unanimously approved.

RR4940481 MONON 30 HOSPITALITY GROUP LLC – Chair Allen noted this is a transfer with the local board voting 3-0 to approve with 1 abstention.

Commissioner Maginn stated the permittee has several convictions, but all over ten years old.

Commissioner Maginn moved to uphold the local board's recommendation to approve. Commissioner Jones seconded. The motion was unanimously approved.

RR4900301 TIKAL #2, INC. – Chair Allen noted this is a renewal with the local board voting 4-0 to approve. There was 1 remonstrator present.

Commissioner Maginn stated the remonstrator was concerned about lack of security at the establishment, noise, trash and violence in the area. There have also been tobacco violations issued. The permittee stated they would be more aware of the noise and keep it under control.

Chair Allen mentioned that there was discussion at the local board about a neighborhood petition being circulated, but the local board officer has not received that petition.

Commissioner Maginn moved to uphold the local board's recommendation to approve the permit for 1-year. Commissioner Jones seconded. The motion was unanimously approved.

RR5440444 AND RR5440445 RJIMENEZ LLC – Chair Allen noted these are new applications with the local board voting 4-0 to deny.

Commissioner Maginn stated this location has been a problem in the past with a different permittee due to an undisclosed owner who is also the landlord. The receipt from the Secretary of State's office regarding the new business shows the fees being paid by the landlord, who is not listed on the ownership. There is also a question regarding another who is not listed but may be the actual owner.

Commissioner Maginn moved to uphold the local board's recommendation to deny. Commissioner Jones seconded. The motion was unanimously approved.

MM4930419 BREWDOG INDIANAPOLIS LLC – Chair Allen noted this permit was expired and renewals have been submitted with a request for the permit to be placed in escrow. That request stated the brewery closed on April 14, 2022. Per statute, brewery permits may be revoked if business ceases operation for 6 months without prior authorization from the Commission. The Chair stated this type of permit is not on quota and could be applied for in the future.

Commissioner Maginn moved to schedule a revocation hearing on January 9, 2024 at 10 am. Vice Chairman Payne seconded. The motion was unanimously approved.

RR2938865; RR2938748; RR2938747 WATSON HOLDINGS LLC – Chair Allen noted this was continued from the November 21, 2023 meeting.

Commissioner Maginn stated the permittee submitted a large number of documents on Friday, which did not leave time for review.

Commissioner Maginn moved to continue this until January 17, 2024. Commissioner Jones seconded, noting he also did not have time to review the 65-page document. The motion was unanimously approved.

RR4939005 MASSIVE LLC – Chair Allen noted this is a request for extension.

Commissioner Maginn moved to approve a 90-day, fee-waived extension, due to a processing error. Commissioner Jones seconded. The motion was unanimously approved.

RR4935258 CONDADO TACOS 10, LLC – Chair Allen noted this is a request for extension.

Commissioner Maginn moved to approve a 2nd extension while the process for ownership changes is being completed. Commissioner Jones seconded. The motion was unanimously approved.

RR5330229 HHM MANAGEMENT SUB LLC – This request for extension was added to the agenda by consent.

Commissioner Maginn moved to approve the 2nd extension while renewals and ownership documents are being processed. Commissioner Jones seconded. The motion was unanimously approved.



Noteworthy Violations for 12/19/23 Commission Meeting

TC11731001: iVape eCigs in Terre Haute, Vigo County. On June 23, 2023, District 5 Excise officers Amber VanNess and Josh Clifford conducted a permit visit at the business. During this visit, officers located eighteen packs of contraband cigarettes and twenty-five counterfeit Mr. Fog Vape products for sale. **The parties have agreed to a \$2,000 civil penalty and a 15-day suspension of the tobacco certificate.**

TC15875001: Angola Tobacco and Vapor (DBA: Thunder Tobacco & Vape) in Angola, Steuben County. On July 14, 2023, District 2 Excise officers Doug Schwertfager and Markus Oster conducted an investigation and observed a juvenile purchase a vape product from the business. It was determined that the on-duty clerk did not ask for the juvenile's age or identification when inside the store or when he purchased the vape product. This was the third violation in 2023 for the sale of a tobacco product to a minor. **The parties have agreed to a \$1,000 civil penalty and a 3-day suspension of the tobacco certificate.**
