The Indiana Department of Environmental Management (IDEM) intends to issue a Hazardous Waste Corrective Action Complete Without Controls determination to:

IDEM has reviewed the administrative record and has drafted a Statement of Basis proposing to end the Hazardous Waste corrective action process. The Statement of Basis supports IDEM's decision to issue a Hazardous Waste Corrective Action Complete Without Controls determination for this facility. IDEM has determined that "No Further Action" is required at any of the Solid Waste Management Units (SWMUs) or Areas of Concern (AOCs). IDEM is providing the public an opportunity to submit written comments and/or request changes to the Statement of Basis as proposed. IDEM is particularly interested in receiving comments from persons aware of any past spills or releases that may have occurred at this facility.

You may request IDEM hold a public hearing or a public meeting. At a public hearing, you would have the opportunity to submit oral or written comments. At a public meeting, you would have an opportunity to submit written comments, ask questions, make statements, and otherwise discuss any concerns about the Statement of Basis, the Corrective Action Completion Determination, or the administrative record with IDEM staff. IDEM will formally respond to any comments received during the public hearing or public meeting in its Response to Comments at the time of its decision. If a public hearing or meeting is held, IDEM will make a separate announcement of the date, time, and location of that hearing/meeting 30 days in advance.
