Indiana Department of Labor Renews Strategic Safety and Health Alliance with the Sheet Metal and Air Conditioning Contractors National Association, Indiana Chapters and Sheet Metal Workers International Association, Local 20

INDIANAPOLIS (July 12, 2010) – Representatives from the Indiana Department of Labor (IDOL), the Sheet Metal and Air Conditioning Contractors National Association (SMACNA) and Sheet Metal Workers International Association, Local 20 (SMWIA) gathered on July 9, 2010 to resign a strategic safety and health alliance agreement.

The goal of the alliance is the further advancement of safety and health in the workplace and the interchange of information, best practices and sharing of resources. INSafe, the IDOL's OSHA consultation division, will provide SMACNA members expertise in the recognition and prevention of workplace safety and health hazards by providing on-site consultation, industrial hygiene monitoring services and training assistance. The alliance agreement also recognizes the longstanding relationship between private consulting firm, Safety Resources, Inc. and SMACNA.

SMACNA will annually report key injury rate numbers in an aggregate form to IDOL for the purpose of tracking overall trends in injury rates for the association. Additionally, SMACNA will share information with IDOL personnel and industry safety and health professionals regarding best practices or effective approaches and publicize results through outreach by SMACNA and through IDOL events, print media, etc.
