CLEAN WATER INDIANA REPORT

Executive Summary:

Administered by the State Soil Conservation Board (SSCB), the Clean Water Indiana (CWI) Grants Program is funded through the CWI Initiative. The purpose of the CWI Grants Program is to provide financial assistance to Soil and Water Conservation Districts (SWCDs) to implement conservation practices to reduce non-point sources of water pollution through education, technical assistance, training, and cost share programs.



2010 CWI GRANT

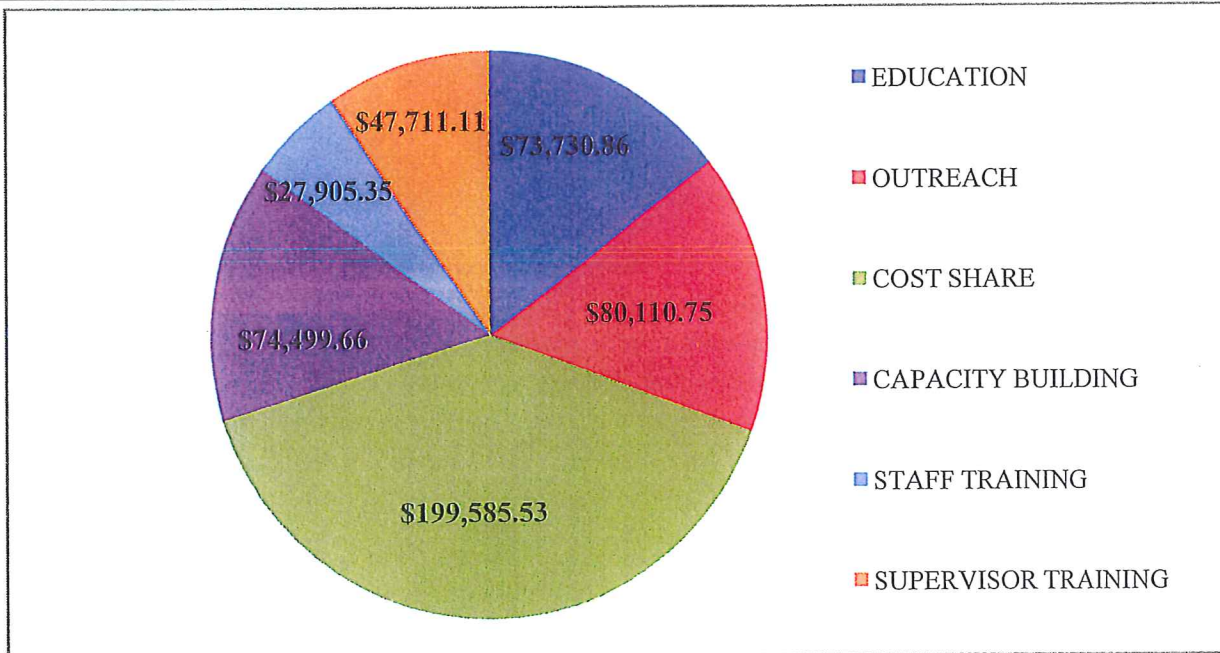
PURPOSE OF GRANT:

For 2010, the State Soil Conservation Board (SSCB) designated \$550,000 for this grant cycle, as well as provided more choices for the use of grant funds. Each Soil and Water Conservation Districts (SWCDs) was given the opportunity to apply up to \$7,000. The focus for this round of grant funding includes:

- Adult Education
- Outreach/Marketing
- Cost Share Incentives
- Capacity Building
 - Staffing
 - Leadership Development Training

88 SWCDs applied for the 2010 CWI grant totaling \$584,409. The SSCB approved all grant applications and funded the total amount applied. All 2010 CWI grants have one year to complete their project, except for Leadership Development Training. Projects start January 1, 2010 and must be complete by December 31, 2010. Leadership Development Training reimbursement may include training from July 1, 2009 through December 31, 2010.

BREAK DOWN OF 2010 CWI GRANT FUNDS PAID (BASED ON CURRENT REPORTED SPENDING \$507,715.25)

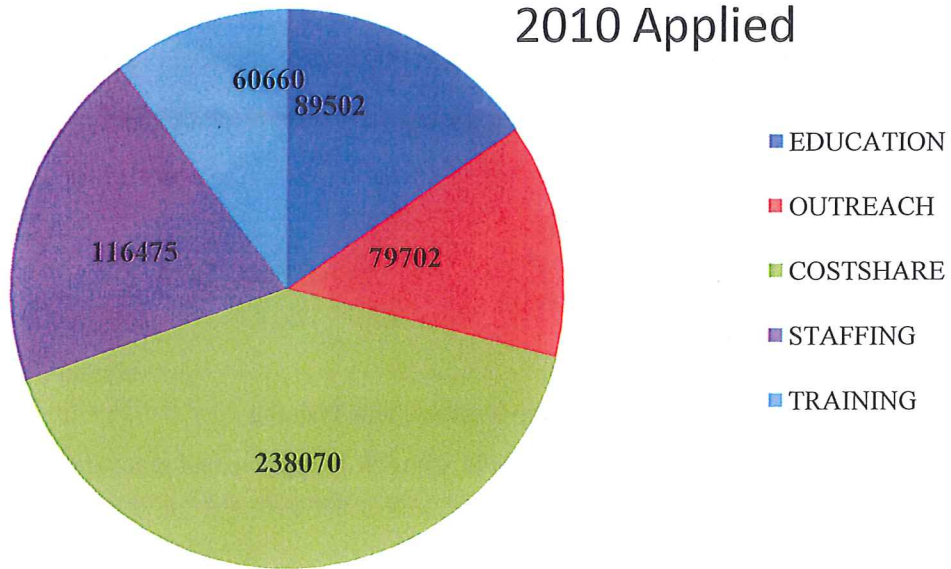


STATUS UPDATE:

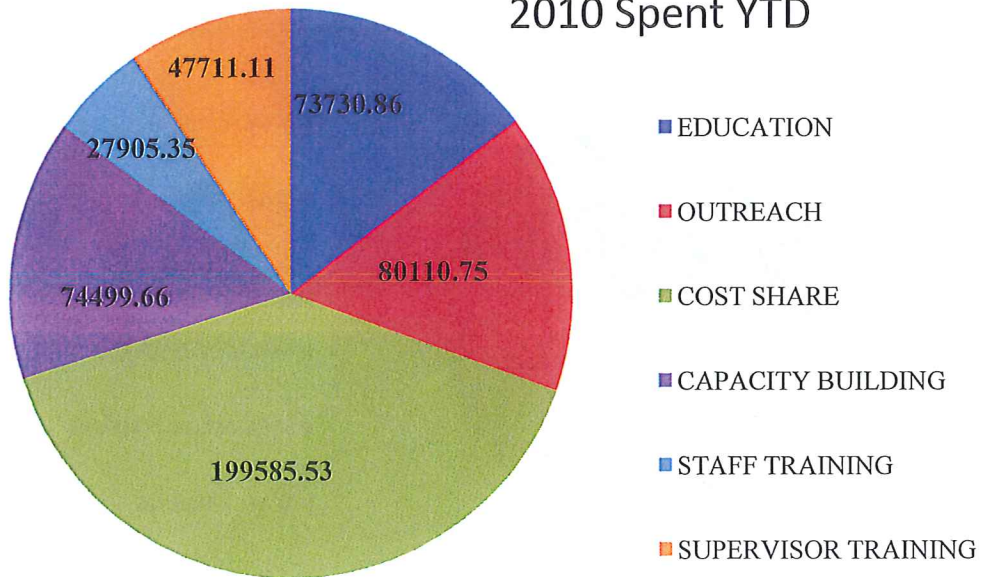
- 76 Districts have submitted a final report and final payment has been issued. A total of \$537,665.11 has been paid. \$2530 has been liquidated.

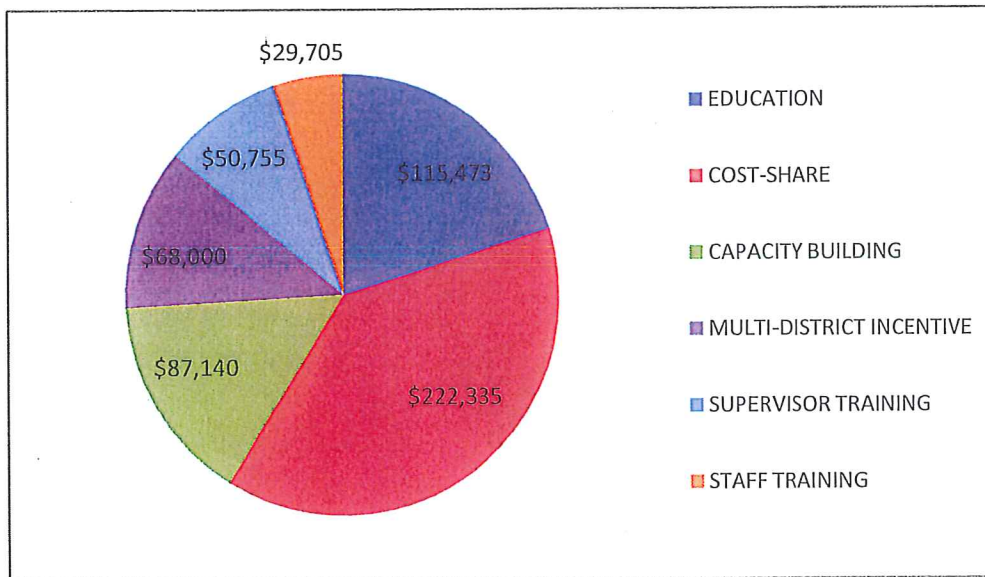

2011 CWI WATERSHED GRANT

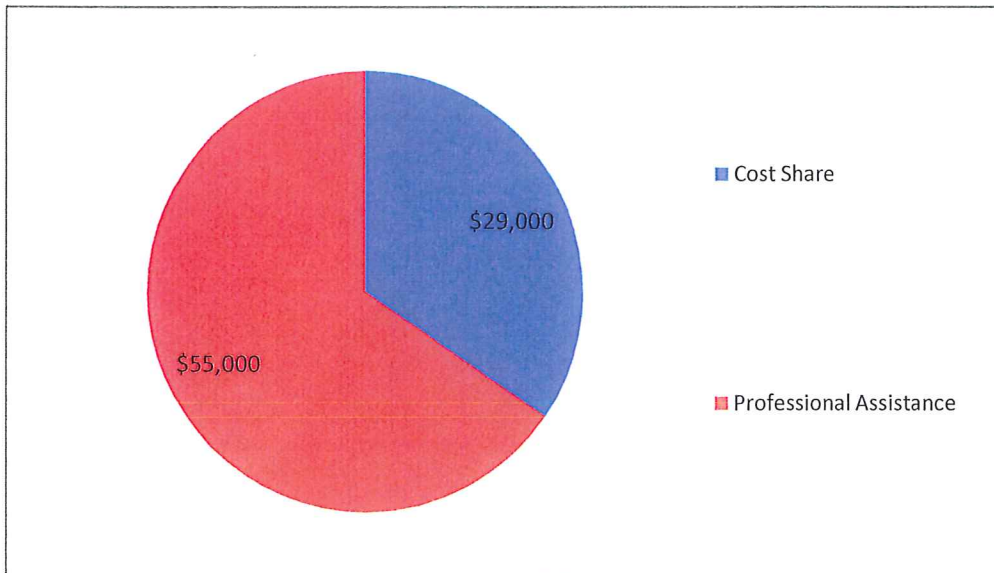
PURPOSE OF GRANT:

For 2011, the State Soil Conservation Board (SSCB) awarded \$84,000 for competitive watershed-based grants. Projects are to fund one or more of the categories listed below:

- Cost Share/Incentives/Demonstrati
- Increase Direct Professional Assist

18 applications were received for the 2011 CWI grant totaling over \$500,000. The SSCB approved 5 grant applications and awarded a total of \$84,000.

2012 Clean Water Indiana Watershed Grant Program
Indiana State Department of Agriculture
State Soil Conservation Board

Executive Summary: The Clean Water Indiana (CWI) Grant Program (IC 14-32-8-5) utilizes the Clean Water Indiana Fund to support Indiana Soil and Water Conservation Districts (SWCDs) in efforts to **reduce sediment and nutrients** from nonpoint sources to help improve water quality. The State Soil Conservation Board (SSCB) has voted to utilize \$XX,XXX of the Clean Water Indiana Grant Program funds to support competitive proposals for multi-district, multi-year watershed projects. Project proposals can be for up to three years and grant funding can be used to help support one or more of the funding categories listed below:

Cost Share/Incentives/ Demonstrations
Increase Direct Professional Assistance to Land users

General Grant Guidance:

- Two or more districts must be actively involved in the watershed project/initiative proposed. A lead district must be selected to serve as the grantee to receive and administer the grant. However, grant funds can be shared between the districts through cooperative agreements developed locally.
- The grant proposal must document how the grant funds will address at least two of the State priorities in the State Soil Conservation Board's (SSCB's) Business Plan adopted in 2010 and identified as follows:
 - **Soil Quality Degradation** which includes the loss of top soil due to erosion, the depletion of organic matter, as well as soil compaction and other soil biology impacts that degrade soil quality.
 - **Water Quality Impairments** including sediment, nutrients, pesticides, *E-coli* and other non-point sources of water pollution found in our streams, rivers and lakes.
 - **Other soil and water related natural resources concerns** including forest lands, wildlife habitat areas, pasture and forage lands and air quality.
- Proposals that support current state and/or national initiatives are strongly encouraged. Examples of state and national priority initiatives include: projects/programs to reduce sediment and nutrient loading into the Gulf of Mexico (MRBI) and the Great Lakes (WLEB and GLRI). Current examples of initiatives partially assisted with Clean Water Indiana funding include the Conservation Reserve Enhancement Program (CREP), On-Farm Network (OFN), and the Conservation Cropping Systems Initiative (CCSI).
- Proposals that outline how the CWI finds will leverage additional funding from other sources as well as engage other partners are strongly encouraged.

Application Process: Application forms are available in SharePoint and should be submitted in SharePoint. See SharePoint tutorial if there are any questions regarding forms in SharePoint.

Application Deadline: The application must be submitted by 4PM on September 16, 2011. By electronically submitting the application, the lead SWCD certifies each partnering district has agreed to the terms outlined in the application.

Eligible Applicants: The multi-district, watershed based applications may be submitted by any SWCD in the State of Indiana; however, only one application is permitted per project and must be submitted by the designated lead SWCD. **All participating SWCDs must be current on reporting.** Please note: Future Clean Water Indiana funding for identical projects/initiatives may not be available until ongoing projects are complete. Participants in the 2011 Clean Water Indiana Watershed Grant Program are exempt from this.

Project Description: The size and number of the targeted watershed(s) shall be determined at the local level. The selected watershed(s) shall encompass lands located within at least two districts. The proposal must identify the current non-point source water quality concerns in the selected watershed(s). If the watershed(s) selected is/are included in an existing Watershed Management Plan or one currently under development, please include the name of the plan and identify who developed it or is developing it.

Partnerships: SWCDs **must** partner with at least one other district and are encouraged to partner with other organizations. Each application must state clearly what each partner (particularly partner district(s)) will be contributing to the proposed project in the grant application (i.e. outreach, professional assistance, estimated funds, etc.).

Funds Available: Each applicant will be given the opportunity to apply for funding under one or both of the grant funding categories. Please see the **Grant Funding Categories with Descriptions** on the next page for additional information. Please note this grant opportunity will be competitive. The SSCB is looking for proposals up to \$60,000, however considerations will be made for exceptionally strong proposals.

Match Requirement: A 50 percent cash and/or in-kind match is required. Match contributions can be federal, state any/or local sources including such things as landowner costs, staff time, equipment use, purchase, or rental, etc. The match is applicable only if directly related to the purpose of the proposed project.

Project Dates: All 2012 Clean Water Indiana Grant Watershed project(s)/initiative(s) shall take no longer than three full years to complete. **Projects may start on January 1, 2012 and must be finished by January 1, 2015.**

Funding Restrictions: Proposals must fall within the funding context allowed under the Clean Water Indiana Law (IC 14-32-8). The law prohibits funds to be used for food, food related paper products, office equipment or district self-promotional materials (examples include mugs, t-shirts, pens, etc). **NOTE: Districts with past due reports on previous CWI Grants will not be eligible to apply for additional CWI Grants until past due grant reports are submitted.**

Leveraging Funds: SWCD's are encouraged to partner with traditional and non-traditional organizations/agencies at the local, state and federal level to leverage additional dollars for their project/initiative. However, the SSCB will show preference to projects which do not add to the percent cost share/incentive rate offered through another program.

Process of Payments: Once the proposal is approved by the SSCB, the Indiana State Department of Agriculture (ISDA) will issue a contract to the designated lead SWCD. SWCDs should return their signed contract to ISDA within 14 days of receipt in order to receive their funds. Funds must be utilized in a timely manner. Districts will receive 75 percent of their grant funding up front and the remaining 25 percent at the end of the project, upon receipt of the final report.

Reporting Requirements: Annual reports through SharePoint will be required for the duration of the grant project and a final report will be due at the end of the grant period. This report must summarize the outcomes and achievements of the project. Tracking of conservation practice implementation must be reported through SharePoint's conservation practices tracking system.

Grant Funding Categories with Descriptions:

Cost-Share/Incentives/Demonstrations: Practices and measures must be focused on the reduction of sediment and nutrients for the proposed watershed(s). Districts are encouraged to provide matching dollars and to leverage additional dollars from other sources. Conservation practices and structural measures shall follow NRCS Field Office Technical Guide where applicable. New technologies not currently in the technical guide may be implemented if reviewed and concurred in by a technical representative of the Conservation Implementation Teams (CIT) or their designee. Districts also have the ability to assist in the purchase/lease or off-set of rental costs for equipment to encourage new technology adoption. Districts may also want to offer financial assistance for demonstration projects or farm comparison plots to demonstrate and evaluate options for reducing erosion and /or nutrient inputs or adoption of new equipment technologies. The SSCB will show preference to projects that are not fundable by other programs, or which do not add to the percent cost share/incentive rate offered through another program.

Direct Agronomic, Technical and Conservation Program Participation Assistance: Funding under this category is for the purpose of increasing the amount of direct agronomic, technical and conservation program planning/participation assistance to land users in the target watershed(s) who are willing to adopt best management practices and technologies for sediment and nutrient reduction. Examples of how funding in this category might be used include:

- **Contracted Services** – Funding under this category may be used for contracts or fee based agreements with individuals, firms, organizations or project partners who can provide additional on-site agronomic and/or other technical assistance to land users to help them plan and implement best management practices and technologies that will reduce erosion and sedimentation and/or improve nutrient management. This may include helping land users understand what conservation program assistance is available to address these resource concerns and helping them apply for conservation program assistance.
- **Matching Funds for Additional Professional Assistance** –Funding in this category may also be used as match to help partnering districts acquire additional personnel to provide the types of professional assistance described above on a watershed wide basis. Examples include but are not limited to: Watershed Technician, Watershed Agronomist, Conservation Program Specialist (agriculture or urban), On-Farm Network Specialist, and Conservation Cropping Systems Specialists.

- **The Storm Water Specialists have been conducting audits of the MS4 Construction Site Run-off Control Program. Audits of all MS4 entities in the state (188) should be completed in 2012. Reggie Korthals, MS4 Coordinator for IDEM is busily working to complete the MS4 audit for program components: Public Education, Public involvement, and Good housekeeping. She should complete this portion of the audits by the end of 2011.**
- **IDEM recently held an annual meeting for MS4 entities. The meeting was well attended and included a program to provide information and compliance assistance to MS4s. SWCD staff that are actively involved with MS4s, either through education and/or technical assistance also attended the meeting.**
- **The Storm Water Specialists are also working one on one with SWCDs on plan review and site inspections for Rule 5 projects.**
- **Work continues with INDOT to address program compliance with Rule 5, including plan review and site inspection of permitted INDOT projects. This work is taken on by each Regional Storm Water Specialist. In addition, IDEM is working with INDOT to revise standards and specifications for practices and assessing the effectiveness of procedures. IDEM also serves on a contractor led group that is working to improve the performance and understanding of contractors.**
- **In addition, to MS4 (Rule 13) and Rule 5 (Construction Site Run-off), the Storm Water Program also administers industrial storm water permits. Megan Nagle, Storm Water Specialist with primary responsibility for this portion of the program will be transferring to another section of IDEM. During her time in the Storm Water Program, Megan has elevated the effectiveness of the Rule 6 program. At this time, we are assessing our options to fill her position.**
- **The Wetlands Program is also undergoing several changes. Brad Baldwin has left the program to return to DNR. In addition, Liz Pelloso will be leaving for a new position with the EPA in Chicago. We will be requesting approval to fill both of these positions. In the interim, current wetlands staff is splitting up the duties to ensure permits are issued in a timely manner.**
- **IDEM has been working on a new agency wide database. The Storm Water Program was one of the first to be involved in the development of the database and an on-line permit application for Rule 5 and Rule 6. To date, Rule 6 is live and we are accepting applications on-line. Final testing for Rule 5 was completed last week. Final instruction and help text still needs to be completed. Once that is accomplished, Rule 5 will also be available to applicants to file Notices of Intent on-line.**
- **The past year, the Wetlands and Storm Water Section has been reporting directly to Martha Clark Mettler, IDEM Deputy Assistant Commissioner. This last quarter, the Wetlands and Storm Water Section became part of the new Surface Water, Operations, and Enforcement Branch. Mary Hollingsworth was recently chosen to be the new Branch Chief.**

NRCS State Conservationist Report

Local Work Group Meetings

This year NRCS is asking the Local Working Groups to meet earlier in the year than in the past, and to discuss how well Indiana's current technical information and programs address the local resource concerns. Soil and Water Conservation Districts and District Conservationists are encouraged to hold meetings and submit feedback as soon as possible so data can be entered into the NRCS system by August 19.

WRP Funding

NRCS is still accepting applications for the Wetlands Reserve Program (WRP), which funds easements and restoration work. Easement values are based on Geographic Area Rate Caps (GARC) values, which increased five percent for 2011. Title to the land remains with the owner. If restoration work is needed, NRCS pays 100 percent of the costs, up to set maximum caps. NRCS is asking for help from SWCDs in promoting WRP on eligible lands.

FY2011 Contribution Agreements

NRCS is again interested in entering into Contribution Agreements with SWCDs for Administrative and Technical Assistance. Assistance is needed for the Conservation Reserve Program (CRP), Environmental Quality Incentive Program (EQIP) and the Conservation Security Program (CSP). Proposals should be submitted to NRCS by June 24, 2011.

Cover Crops in a Wet Spring

NRCS has been promoting the benefits of cover crops, even though some farmers have had to adjust management plans due to the wet spring. A recent NRCS news release included a quote from Barry Fisher, State Agronomist, "In a wet year cover crop growth can be much farther along than planned, so the management decisions on how to kill the cover crop have to be adjusted. Under these conditions a faster acting herbicide may be needed. However, cover crops are still worth the investment because they stabilize moisture levels and reduce erosion, scouring and nutrient losses." The news release promoted the Conservation Cropping System Initiative (CCSI), explaining that when used as part of a conservation cropping system, cover crops increase soil productive health and decrease risk, no matter what the conditions. Fields have less erosion and better moisture management with a cover crop, lessening risks from drought or flooding.

RC&D Closeout

While the RC&D Program in the Farm Bill has not been deauthorized, the funding has been zeroed out for FY2011. While NRCS agreements funded with RC&D dollars are being terminated, other agreements with Councils, where work can continue without NRCS staff support, are being maintained. NRCS will continue to work with RC&Ds as a strong conservation partner in Indiana, regardless of RC&D funding through the Farm Bill.

Watershed Operations Closeout

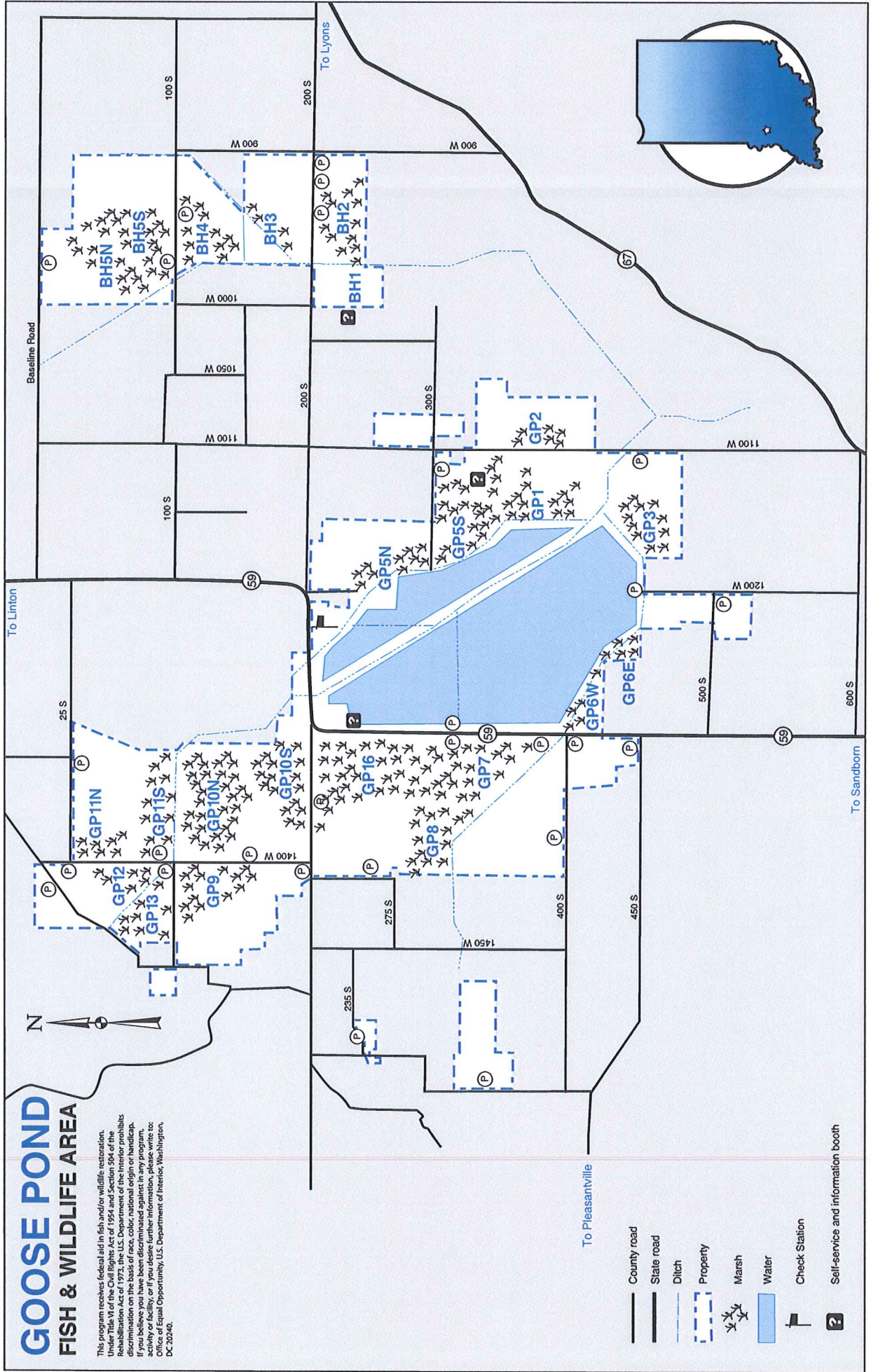
While the Watershed Operations Program has not been deauthorized, the funding has been zeroed out for FY2011. Indiana NRCS does not currently have any funded Watershed Operations projects or staff. Watershed Operations funding is authorized to pay for publicly sponsored projects with benefits directly related to agriculture, such as building or repairing floodwater retarding dams and reservoirs.

Continuity of Operations Earthquake Exercise

Indiana's USDA agencies participated in a mock disaster exercise May 16-19. The purpose of the exercise was to be fully prepared for a large scale earthquake should one ever occur in the state.

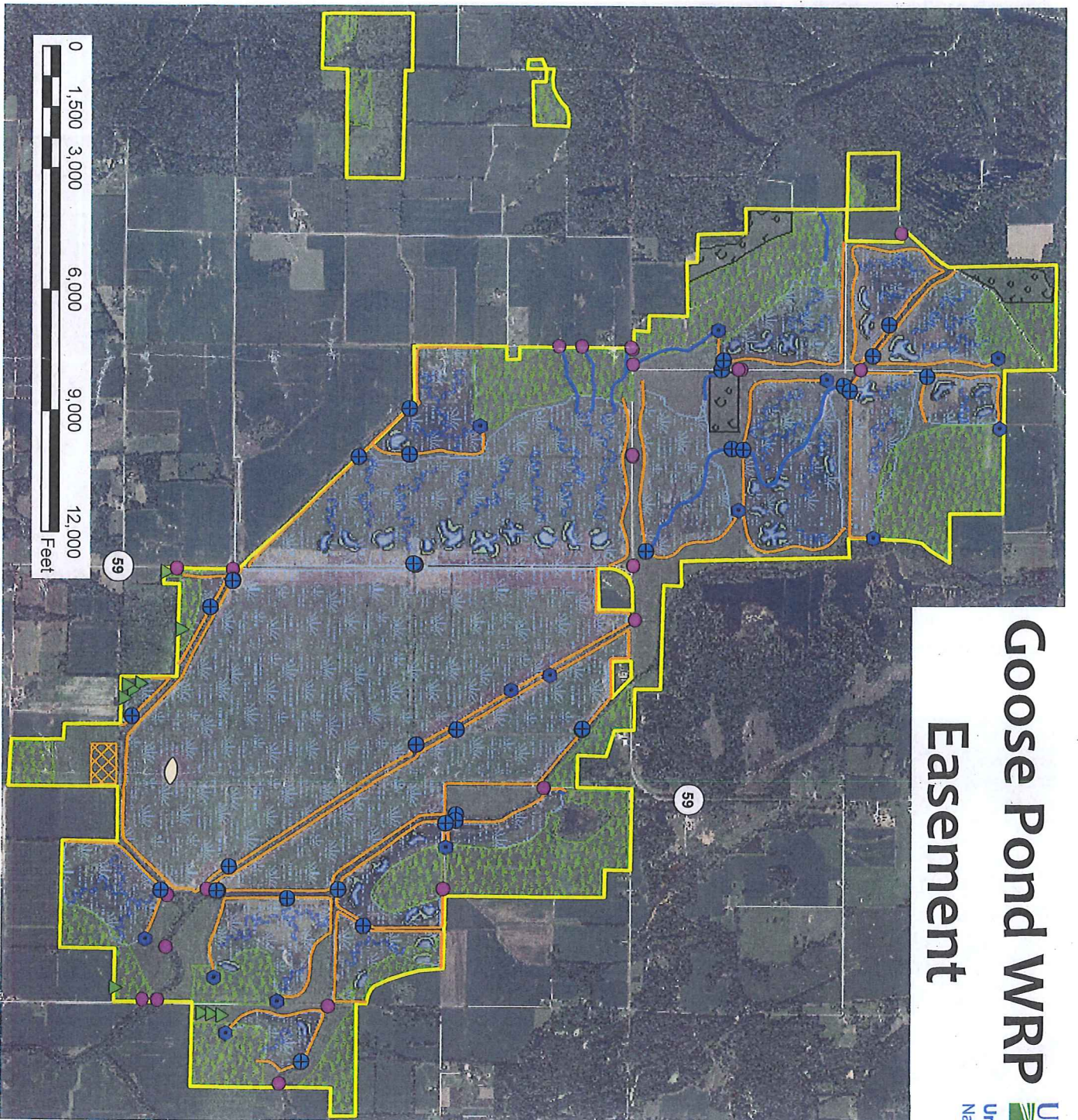










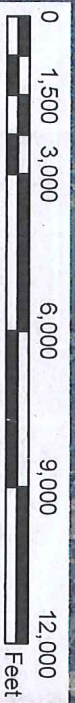
Goose Pond WRP Easement

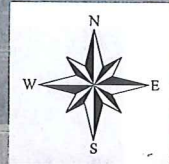


Beehunter Marsh WRP Easement
