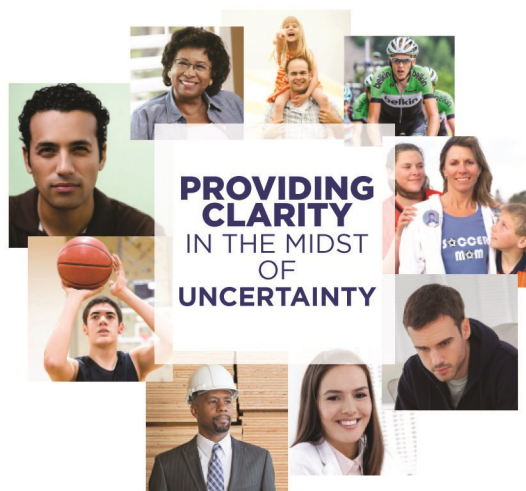

Dear Special Guests:

Welcome to our 5th Annual Prescription Drug Abuse Symposium.

50 Americans die each day from prescription drug overdoses and more than 6 million suffer from prescription drug abuse disorders. Drug overdoses were blamed for 999 deaths in Indiana in 2012, a 57% increase over the past decade. That is why I am committed to fighting this epidemic as long as I serve as Indiana's Attorney General.

Although we face an uphill battle, we have begun to shift the paradigm of pain management from one that relies heavily on opioids to one based on comprehensive assessments and treatment plans aimed at improving patient's functionality and overall quality of life. Indiana's new Emergency Opioid Prescribing Rules went into effect December 15, 2013. Since that time, Indiana has seen a decline of almost 11% in the amount of opioids that are being prescribed to patients. We hope to see an even greater decrease as the permanent rules take effect on November 1, 2014.

A priority of our Prescription Drug Abuse Prevention Task Force is advancing legislation to help combat the problem of prescription drug misuse and diversion. During the 2013 legislative session, members of the Task Force helped pass Senate Enrolled Acts 227 and 408, and House Enrolled Acts 1360 and 1218. Today we will be hearing more on these policy solutions and other legislative proposals from your state legislators that are committed to reducing this epidemic.

SEA 227 provides immunity to first responders to utilize naloxone (Narcan), a medication that counteracts the effects of an opioid drug overdose, including heroin. SEA 408 focuses on standardizing screening and reporting of Neonatal Abstinence Syndrome. HEA 1360 offers student loan forgiveness grants to mental health and addiction professionals who commit to practicing in Indiana. HEA 1218, reduces the time for controlled substance prescription dispensing information to be sent to INSPECT to reach near real-time reporting standards starting January, 2016.

Several other Task Force accomplishments include: our partnership with the Indianapolis Colts to heighten awareness of this epidemic; the launch of our Train the Trainer public outreach program; the free online CME course entitled "The Opioid Epidemic and Indiana's Opioid Prescribing Laws"; and our 85+ outreach seminars/webinars presented to prescribers statewide since the implementation of the opioid prescribing laws. It has been a year full of hard work and success, but there is still a long way to go. Our Task Force is committed to fighting this public health problem and welcomes your help to identify and implement new solutions.

My personal thanks to the hard work of our Task Force members, all of our speakers for volunteering to present at today's program, and to those lending financial support. This program would not be possible without the efforts from all of those involved. We hope all participants benefit from the program and are able to apply the learning objectives presented today to continue addressing this issue in our state.

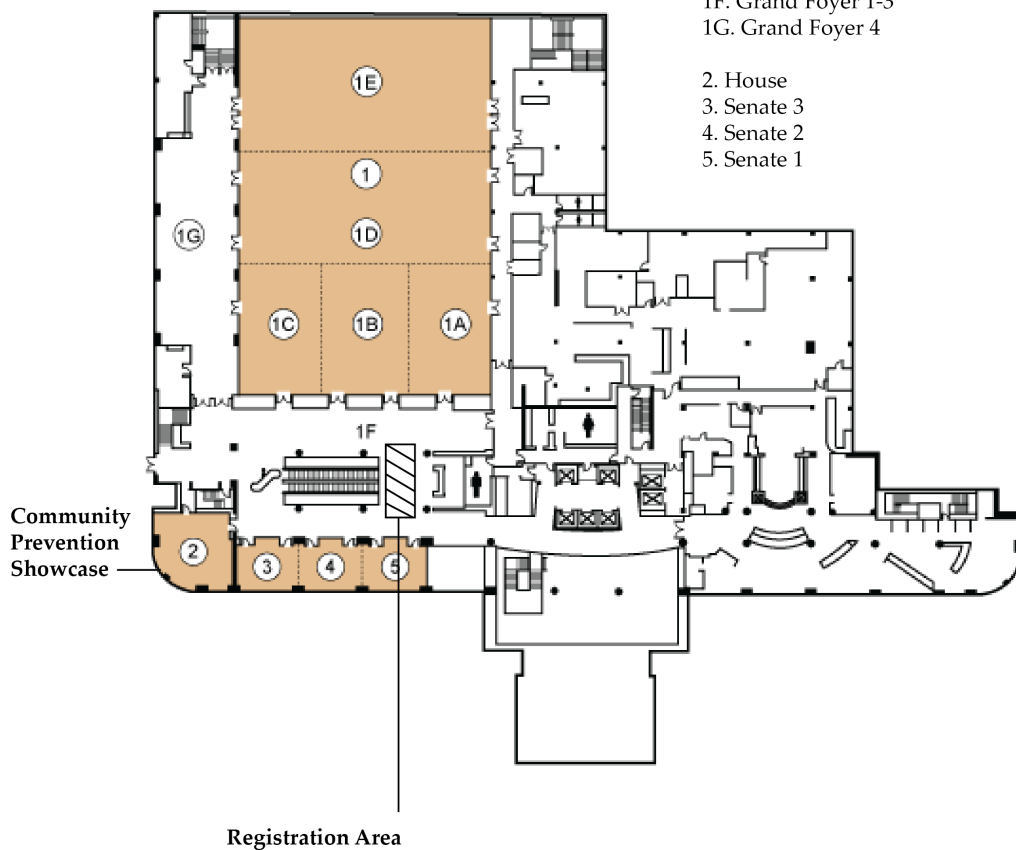

Disciplinary Focused Workshops: 1:30 pm – 3:00 pm

Case Study Review of Chronic Pain Patients

Subject matter experts will co-facilitate workshops which will aim to inform the audience about ways to manage the complexities involved with chronic pain patients as it relates to each unique discipline. Attendees will work through case studies to assess prescribing of opioids to chronic pain patients that are either at high risk of substance abuse and addiction, diverting their opioid prescriptions, abusing them in conjunction with other illicit drugs, or those that are on high doses of opioids and are not showing any signs of improved functionality. Oftentimes, some of these chronic pain patients eventually will be denied access to opioids whether it be through their physician or pharmacist and/or may be in need of treatment services. The physicians prescribing to these chronic pain patients may find themselves subject to consumer complaints and investigations and/or licensing enforcement actions. All of these scenarios will be discussed among the following four disciplines: Law Enforcement, Clinicians, Mental Health and Addiction Professionals, and Pharmacists.

Learning Objectives

- Gain insight from experts and knowledge from shared experiences among colleagues as they relate to your discipline in dealing with issues surrounding chronic pain patients
- Discuss the challenges and barriers related to managing, treating, dispensing to, and/or investigating cases that involve chronic pain patients
- Explore solutions to the complexities involved with the prescribing and dispensing of opioids to chronic pain patients, as well as address issues related to addiction and medication diversion

Panel Discussion: 3:15 pm – 4:45 pm

Navigating Medical Legal Challenges Involving Chronic Pain Patients

After meeting within their respective disciplines, attendees will come together to discuss potential medico-legal issues that were raised. Experts from the fields of medical practice administration, pain management, pharmacy practice, law enforcement, and mental health and addiction will offer perspectives on the legal challenges that were raised during the breakout sessions and guide attendees to address them through cross collaboration. By the end of this panel discussion, attendees will have a better understanding of how their individual disciplines work within the larger system of responsible prescribing for chronic pain management and how to effectively collaborate with system partners

Learning Objectives

- Understand the multi-disciplinary approach needed to address the treatment and care of chronic pain patients from a clinical, addiction treatment, pharmaceutical, and law enforcement perspective
- Gain awareness of the legal challenges faced by different situations involving chronic pain patients
- Assess and build upon areas of collaboration among all four disciplines; clinicians, pharmacists, mental health and addiction professionals, and law enforcement

**Keynote Address: 8:50 am—9:50 am****Building the Infrastructure to Stem the Flow of Rx Drugs & Addiction**

Dr. Jeffrey Coady from the Substance Abuse and Mental Health Association (SAMHSA) will discuss evidence-based prevention strategies for prescription drug abuse. A strong behavioral health system is essential for reducing prescription drug abuse. This can only be achieved through partnerships in public health, clinical medicine, and public safety. This keynote presentation will identify cross-sector emerging best practices for advancing behavioral health prevention, treatment, and recovery. Implementing such practices and strategies can put Indiana on a path to eliminate prescription drug abuse, thereby creating safer and healthier communities.

Learning Objectives

- Demonstrate how evidence-based prevention strategies can help address the issue of prescription drug abuse more effectively
- Identify best practices that can be used to identify a problem, further investigate an issue and generate community interest
- Explain a multi-faceted approach to prevent prescription drug overdose and abuse

General Session: 9:50 am—10:50 am**Under the Bridge: Insider Look at Rx Drug Abuse within the Healthcare Setting**

Rodrigo Garcia, CRNA, will discuss contemporary examples of addiction and his personal experience working within a healthcare setting while addicted to prescription drugs. As an anesthesia provider, Rodrigo was exposed to some of the world's most potent medications. He will share his story of addiction and recovery, highlighting diversion tactics, monitoring inconsistencies, as well as system failures and the consequences of drug diversion in health care settings. He will conclude his presentation with proposed solutions, the future of addiction, and some thoughts on hope and affirmation. Information from this session can help health care providers recognize the warning signs of abuse amongst their coworkers, as well as establish effective protocols for preventing diversion within the healthcare setting. Join us as he walks us through his experience of chemical dependency that nearly took his life, the steps he took to overcome it, and his new found passion to help others.

Learning Objectives

- Recognize techniques that drug addicts use to obtain medications within the healthcare system
- Evaluate prescription drug monitoring inconsistencies within the healthcare system and explore possible remedies
- Analyze prevention measures that can be taken to reduce drug diversion within the healthcare setting and ways to proactively refer those addicted to treatment services



Breakout Session: 11:00 am—Noon

Corresponding Responsibilities for Providers and Dispensers

DEA Agent Joe Rannazzisi returns to the symposium to discuss the corresponding responsibilities of providers and dispensers. According to government estimates, about 131 million prescriptions for hydrocodone-containing medications were written in 2011, which amounts to about five billion pills. While the responsibility for the proper prescribing is upon the prescriber, an additional responsibility rests with the pharmacist who dispenses the prescriptions. This session will focus on responsibilities and collaborative efforts of prescribers and the corresponding efforts needed by pharmacists to provide the best treatment possible for patients. A pharmacist is required to exercise sound professional judgment when making a determination about the legitimacy of a controlled substance prescription, which is not always easy. Participants will examine methods for the pharmacist to use in determining whether any given prescription is valid or invalid. Discussions of what do in the gray areas, what liability exists for filling invalid prescriptions, and what penalties await violators of the law will also be included.

Learning Objectives:

- Identify the legal standard for dispensing medications pursuant to a valid prescription
- Identify the basis and effects of the proposed DEA regulations
- List the factors the pharmacist should consider in determining whether to dispense medication and identify red flags

Breakout Session: 11:00 am—Noon

Integrating Mental Health and Addiction into Primary Care

Primary care physicians are often the first in the health care system to work with a patient, placing them in the optimal position to successfully treat or refer a patient for treatment if necessary. During this panel discussion, David Crabb, Julie Vannerson and Cynthia Wilson with Eskenazi Health will provide strategies for integrating mental health and addiction screening and brief intervention into primary care settings. Attendees in this session will get an inside glimpse at Eskenazi Health as a unique venue that's striving to advance Screening, Brief Intervention & Referral to Treatment (SBIRT) in the training of primary care and allied health care providers given their ability to collaborate within the three disciplines. The purpose is to integrate SBIRT into Indiana's healthcare and allied health care education systems to improve the lives of adolescents and adults at risk for one or more substance use disorders.

Learning Objectives

- Identify ways to reduce prescription drug addiction by first assessing one's risk of substance abuse through screening.
- Evaluate how the integration of mental health and addiction into primary care can be used to decrease prescription drug abuse
- Discuss the impact of intervention on provider, patient and administrative outcomes

**Breakout Session: 11:00 am—Noon****Neonatal Abstinence Syndrome (NAS) —A Cry for Help**

Infants exposed to both illicit and prescription opioids in the womb frequently experience a withdrawal syndrome following birth called Neonatal Abstinence Syndrome (NAS). Research shows a three-fold rise in NAS diagnoses from 2002 - 2009. This session will focus on two Indiana hospital programs that are addressing NAS. Debra Gloyd, RN, of Margaret Mary Community Hospital will discuss the universal screening procedures put in place by the hospital, development of the program, barriers and challenges, as well as findings from the first year. Lacrishia Whitley, RN, will share more about the components of Reid Hospital's NAS Family Centered Care program. Both programs are highlighted as successfully implemented interventions at the hospital level of care.

Learning Objectives

- Understand the universal screening procedures put in place by Margaret Mary Community Hospital to reduce the impact of NAS
- Learn new tools and techniques for identifying and intervening with at-risk women
- Discuss program development, implementation and outcomes faced by both hospitals

Breakout Session: 1:00 pm—2:30 pm**Legislative Panel Discussion: Federal and State Policy Solutions to Combat Rx Drug Abuse**

This panel of legislators will discuss policy solutions to address the prescription drug epidemic in Indiana. State legislators will discuss recent efforts of the Indiana General Assembly and provide a preview of what to expect in the next legislative session. Drawing from the panelists' comprehensive experience as elected officials combatting prescription drug abuse through policy solutions, the audience will gain a better understanding of what actions caused these officials to become involved in the issue and strategies will be shared so that participants can mobilize to more effectively approach their communities with this fight.

Learning Objectives

- Discuss policy solutions that have positively impacted the fight against prescription drug abuse at the federal and state level
- Identify strategies that policy-makers are developing to mitigate this epidemic at the federal and state level
- Outline effective advocacy approaches to enact change with elected officials



Breakout Session: 2:40 pm—3:40 pm

INSPECT—Indiana Opioid Patterns and Behaviors

Opioid use and abuse in the United States continues to expand at an alarming rate. Recent research by Dr. Eric Wright and colleagues used community-level information, Indiana Scheduled Prescription Electronic Collection and Tracking Program (INSPECT) data, and geospatial regression methods to examine county-level determinants of the availability and abuse of prescription opioids to better understand the socio-ecological context, and in particular the role of the healthcare delivery system, on the prescription drug abuse epidemic. Findings suggest that access to healthcare generally, and to dentists and pharmacists in particular, increases the availability of prescription opioids in communities, which, in turn, is associated with higher rates of opioid abuse. An additional research study found that more opioid prescriptions and more prescribers correlated with opioid dependence and personality disorder diagnoses respectively. Prescription drug monitoring is a powerful tool for assessing addictions and high frequencies of patient exposures to prescribed opioids in a dual diagnosis clinic. Results from these studies suggest that the structure of the local healthcare system is a major determinant of community-level access to opioids, adding to a growing body of evidence that the problem of prescription opioid abuse is, at least in part, an “iatrogenic epidemic.”

- Define iatrogenic epidemics and understand how evidence suggests it plays a role in the prescription drug abuse problem
- Identify factors that contribute to high rates of prescription drug abuse in Indiana
- Outline opioid patterns and behaviors in Indiana based on our state’s prescription drug monitoring program, INSPECT

Breakout Session: 2:40 pm—3:40 pm

The Golden Rule: Why Urine Drug Monitoring is Good for Everyone

Evidence indicates that self-reported drug use by chronic pain patients is unreliable and behavioral monitoring lacks sufficient sensitivity to detect substance misuse in a substantial percentage of patients. For example, a recent study found that 21% of chronic opioid patients who displayed no drug-related behaviors had positive UDMs for either an illicit drug or an unauthorized controlled substance. Several recent publications, including the updated version of the text, *Responsible Opioid Prescribing*, from the Federation of State Medical Boards, (author Scott Fishman, M.D.), recommends laboratory urine toxicology testing as an essential ingredient of assessing adherence to prescribed treatment regimens involving controlled substances. During this session, Dr. Trobridge and Dr. Roth will discuss why they agree that UDM is the most practical and objective clinical tool available to prescribers for medically assessing aberrant drug related behaviors in their patients. They will also share practical information on ways to easily implement UDM within your practice without breaking the bank.

Learning Objectives

- Examine how UDM is a practical & objective tool to assess whether patients are taking Rx medications as directed
- Discuss how UDM is a practical and objective tool to assess if patients are taking unauthorized controlled medications or using illicit substances
- Understand how UDM can allow prescribers to evaluate if a patient is taking combinations of medications/substances that may induce adverse drug interactions

**Breakout Session: 2:40 pm – 3:40 pm****Naloxone: Chicago Recovery Alliance (CRA)**

Since 1991, the Chicago Recovery Alliance (CRA) has served the health promotional needs of over 250,000 unique individuals injecting drugs in Chicagoland through harm reduction outreach. Led by the expertise of CRA participants, CRA has developed health promotion efforts over the last 24 years which address the current threats and concerns of those using CRA's outreach. CRA developed the first overdose intervention program with naloxone in 1996. To date, CRA has reached over 36,000 people with overdose prevention and received over 5,500 reports of lay overdose reversal. Founder and Director, Dan Bigg, along with his colleague Larry Pasco, will present more information about this breakthrough prevention effort, discussing the challenges and outcomes.

- Identify the bridge between prescription drug abuse and heroin and discuss solutions
- Analyze the efficacy and best practices for distributing naloxone in an effort to reduce opioid overdose deaths
- Outline strategies for educating and training communities about naloxone programs

A central question in addressing the issue of prescription drug abuse is how to balance the benefit of opioid medications for the appropriate treatment of pain with the risk of contributing to prescription drug misuse and abuse. Primary care providers are often caught in between these competing imperatives. Primary care providers receive little education during training on pain management, and few primary care practices have policies and procedures in place to support providers in treating pain safely and effectively. This session, presented by members of the Indiana Prescription Drug Abuse Prevention Task Force, will introduce the rules on the prescribing of opioids for chronic pain patients as promulgated by the Medical Licensing Board (MLB) of Indiana. Participants will also be offered a comprehensive overview of the Indiana Prescriber Toolkit, *First Do No Harm*, which is designed to guide all prescribers on ways to comply with these new regulations and to properly manage chronic non-terminal pain patients.

Learning Objectives

- Demonstrate how the implementation of the MLB's Opioid Prescribing Rules can enable the identification and targeting of inappropriate behaviors related to prescription drug abuse
- Identify ways the implementation of the MLB's Opioid Prescribing Rules can play a role in improving chronic pain patient functionality and overall quality of life
- Discuss effective strategies to properly manage chronic non-terminal pain patients by using the *First Do No Harm Toolkit* as a guide

Led by the expertise of CRA's participants CRA has developed health promotion efforts over the last 24 years which address the current threats and concerns of those using their outreach. Those efforts include viral hepatitis prevention as the gold-standard of safer injection, STI testing, vaccination, and CRA development of the first overdose intervention program with naloxone in 1996. To date, CRA has reached over 36,000 people with OD prevention and received over 5,500 reports of lay OD reversal.

Nicola Bunick currently serves as Counsel to U.S. Senator Joe Donnelly. He also has a special interest in the treatment of cancer pain including the use of intraspinal infusion pumps. In addition to his clinical pursuits, he is a leader in organized medicine. Dr. Trobridge serves as vice speaker of the Indiana State Medical Association (ISMA), as well as president of the ISMA Young Physician Society. He serves on the ISMA Pain Management and Prescribing Ad Hoc Task Force and the Commission on Legislation.

Greg Zoeller was elected Indiana's 42nd Attorney General in November 2008 and sworn into office January 12, 2009. Zoeller was reelected to a second term in November 2012 and was sworn into office January 14, 2013. Prior to being elected Attorney General, Zoeller served as the chief deputy to his predecessor, Steve Carter, making him the first to have served in the office prior to being elected. In September 2012, Zoeller led the Indiana Attorney General's Prescription Drug Abuse Task Force. In creating the Task Force it was Zoeller's mission to significantly reduce the abuse of controlled prescription drugs and to decrease the number of deaths associated with these drugs in Indiana. As a member of the Consumer Protection Committee for the National Association of Attorneys General, Zoeller serves in a national leadership position. He also serves on the US Department of Justice Executive Working Group to develop greater collaboration and coordination of state and federal criminal justice agencies. Zoeller serves as a member of Indiana's Criminal Justice Institute helping law enforcement agencies with a focus on victim's rights. Zoeller had previously served as Assistant to Vice President Dan Quayle in the White House from 1989-1991 and earlier served then-Senator Quayle in both Washington and Indiana in legislative and executive capacities since 1982. His other government experience includes serving as Special Assistant to the U.S. Attorney General, Richard Thornburg, in 1988 and as Senior Counsel to the House of Representatives Committee on Government Reform and Oversight in 1998.
