

Indiana Official Driver Record (“ODR”) Status Codes

DRIVER’S LICENSE (“DL”) STATUS	DESCRIPTION
CANCELLED	Driving record has been cancelled by the BMV
CONDITIONAL	Driver has restricted driving privileges (e.g., privileges are restricted as per parameters of hardship license or probationary license)
EXPIRED	Driver’s license has expired
FRAUDULENT	Driving privileges are invalid; license was obtained fraudulently
HABITUAL TRAFFIC VIOLATOR	Driving privileges are suspended as a habitual traffic violator
HABITUAL TRAFFIC VIOLATOR – LIFE	Driving privileges are forfeited for life as a habitual traffic violator
INVALID – REVOKED	Driver has no driving privileges (e.g., this status may represent: a driver that is less than eighteen (18) years of age and is a habitual truant, is under a suspension or an expulsion or has withdrawn from school; a minor who has had an individual sign the minor’s license or permit application and then later request to be relieved from liability; or a previously licensed driver whose social security number is not verified with the Social Security Administration)
SUSPENDED - ADMINISTRATIVE	Driving privileges are suspended by the BMV due to an administrative action
SUSPENDED – INFRACTION	Driving privileges are suspended as a result of an infraction
SUSPENDED – MISDEMEANOR	Driving privileges are suspended as a result of a misdemeanor
SUSPENDED – COURT	Driving privileges are suspended as a result of a court order (e.g., a failure to appear (“FTA”), failure to pay (“FTP”), felony conviction, chemical test refusal, or a chemical test failure)
SUSPENDED – PRIOR	Driving privileges are suspended, and driver has had a prior suspension
UNLICENSED	Driver has a record with the BMV, but has not been licensed in Indiana
VALID	Driver has full driving privileges

COMMERCIAL DRIVER’S LICENSE (“CDL”) STATUS	DESCRIPTION
CANCELLED	CDL is cancelled because facts reveal that driver did not qualify for CDL
DISQUALIFIED	Commercial driving privileges are disqualified because driver has committed a disqualifying offense or has violated an out-of-service order
DISQUALIFIED – INDEFINITE	Commercial driving privileges are disqualified for failure to meet or maintain qualification requirements (e.g., commercial driving privileges may be disqualified for failing to meet medical requirements of 49 CFR Part 391)
DISQUALIFIED – LIFETIME	Commercial driving privileges are disqualified for life
EXPIRED	Driver’s CDL has expired
INVALID – NO DL PRIVILEGES	Driver has no privileges to operate a commercial motor vehicle because the driver has no current DL privileges
NONE	Driver has no privileges to operate a commercial motor vehicle
PENDING TRANSFER	Driver has commercial driving privileges, which are being transferred to a new state of record

RETEST	Commercial driving privileges are suspended pending a required retest
TRANSFERRED	Commercial driving privileges have been transferred to a new state of record
VALID	Driver has privileges to operate a commercial motor vehicle within the specified class
VOLUNTARY SURRENDER	Driver has no privileges to operate a commercial motor vehicle because driver has voluntarily surrendered commercial driving privileges

MOTORCYCLE ("MC") STATUS	DESCRIPTION
EXPIRED	Driver's motorcycle endorsement has expired
CANCELLED	Customer's record has been cancelled by the BMV
INVALID – NO DL PRIVILEGES	Driver has no privileges to operate a motorcycle because the driver has no current DL privileges
NONE	Driver has no privileges to operate a motorcycle
REVOKED	Driver's privileges to operate a motorcycle have been revoked (e.g., driver may have been convicted of operating a motorcycle under the influence of alcohol)
VALID	Driver has privileges to operate a motorcycle

IDENTIFICATION ("ID") STATUS	DESCRIPTION
CANCELLED	Customer's record has been cancelled by the BMV
EXPIRED	Customer's ID card has expired
FRAUDULENT	Customer's ID is invalid; credential was obtained fraudulently
NONE	Customer does not have an ID card
VALID	Customer's ID card is valid
