

Directions to the BOAH Offices

From the Northwest: Go south on Interstate 65 to Indianapolis. Take the 38th Street East exit. Drive 5 miles east on 38th street to Fall Creek Parkway (the State Fair grounds are at this intersection). Turn left on E. Fall Creek Parkway North to the third stop light. Turn right (south) onto N Keystone Ave. Drive 0.1 mile to the Mainscape Office Center on your right. The entrance is immediately after crossing the bridge. See **Office Entrance** below.

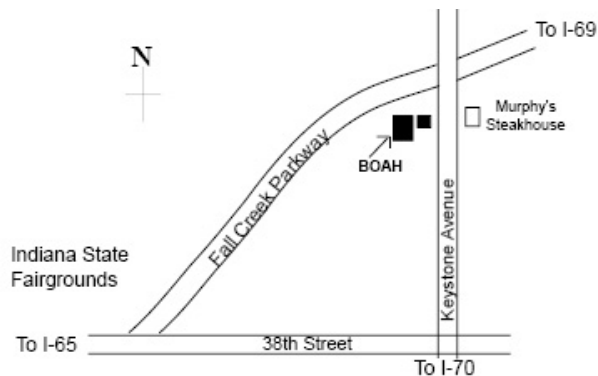
From the West: Take Interstate 465 to the 38th Street East exit. Drive 5 miles east on 38th street to Fall Creek Parkway (the State Fair grounds are at this intersection). Turn left on E. Fall Creek Parkway North to the third stop light. Turn right (south) onto N Keystone Ave. Drive 0.1 mile to the Mainscape Office Center on your right. The entrance is immediately after crossing the bridge. See **Office Entrance** Below.

From the Northeast: Go south on Interstate 69 to Indianapolis. Keep left on I-69 to take Binford Boulevard and go 5.7 miles. Binford Boulevard becomes N. Fall Creek Parkway. Continue on for 0.2 miles, then turn left on Keystone Avenue. The entrance to the Mainscape Office Center is on the right, immediately after crossing the bridge. See **Office Entrance** below.

From the South: Go North on Interstate 65 to Indianapolis. Once downtown, keep right and take Interstate 70 E via exit 112A toward Columbus, OH. Take exit 85 B toward N. Keystone Avenue. Merge on to Rural Street, which turns into Keystone Way. Keystone Way becomes Keystone Avenue. Continue two miles north to the Mainscape Office Center (just North of 38th Street) which is on your left, on the West side of Keystone. See **Office Entrance** below.

From the East: Take Interstate 70 toward downtown Indianapolis. Take exit 85 B toward N. Keystone Avenue. Merge on to Rural Street, which turns into Keystone Way. Keystone Way becomes Keystone Avenue. Continue two miles north to the Mainscape Office Center (just north of 38th Street) which is on your left, on the west side of Keystone. See **Office Entrance** below.

Office Entrance: Drive to your right around the front (2 story) office building to the back (north) side. The BOAH office is in the single story building. The entrance is between the two buildings in the landscaped courtyard area.
