# SECTION ONE GENERAL INFORMATION AND REQUESTED PRODUCTS/SERVICES

#### 1.1 INTRODUCTION

It is the intent of the Indiana Commission for Higher Education to solicit responses to this Request for Proposal (RFP) in accordance with the statement of work, proposal preparation section, and specifications contained in this document. This RFP is being posted to the Commission's website (<a href="http://www.in.gov/che/3171.htm">http://www.in.gov/che/3171.htm</a>). Neither this RFP nor any response (proposal) submitted hereto are to be construed as a legal offer.

#### 1.3 PURPOSE OF THE RFP

The purpose of this RFP is to select a vendor that can satisfy the marketing and outreach efforts that will increase enrollments and completions in high demand, high-value certificate programs as part of the state's Next Level Jobs Workforce Ready Grant program using a budget of \$750,000 over one year.

With an initial marketing investment of about \$1.1M over about two years, 15,280+ Hoosiers have enrolled in these certificate programs. These results are promising and demonstrate growing momentum around the state's Next Level Jobs Workforce Ready Grant program. With a strategy more focused on direct targeting and retargeting individuals in key populations, we believe there is great potential to build from success to-date and grow the number of enrollments and completions in these high-value programs.

#### 1.4 BACKGROUND

Indiana has adopted a bold goal for 60 percent of its working-age population to have some type of credential beyond a high school diploma by 2025. Currently, about 43.4 percent of Hoosiers have earned some credential beyond a diploma. Gov. Holcomb's Next Level Jobs Workforce Ready Grant puts a sharp focus on helping Indiana meet that 60 percent goal by helping connect working-age Hoosier adults and recent high school graduates to high-demand certificate programs that will lead to better paying jobs.

#### How it Works:

The NextLevelJobs.org online portal asks job seekers five simple questions, collects information about their job interests and connects them directly with Ivy Tech Community College, Vincennes University or another approved training provider. Those who submit their information on the portal receive a follow-up email immediately and a call from someone at an education or training provider within two to three days.

Eligible adults receive the Next Level Jobs Workforce Ready Grant, which covers tuition and mandatory fees for Hoosiers to enroll in high-demand, high-value certificate programs. Beyond the Next Level Jobs Workforce Ready Grant, the NextLevelJobs.org online portal connects Hoosiers to other available workforce and postsecondary grants and opportunities.

Target Populations for Next Level Jobs Workforce Ready Grant:

- Those who have visited the NextLevelJobs.org online portal but have not submitted their information for follow-up (About 350,000)
- Those who have visited the NextLevelJobs.org online portal and submitted their information but have not enrolled in eligible programs. (About 35,600)
- High school students who are not following a graduation pathway that leads to a four- or two-year degree program (About 36,000)
- High school students pursuing Career & Technical Education (CTE) pathways (About 25,000)
- High school graduates who did not enroll in a postsecondary education or training program (About 28,016)
- Students who began work at a two- or four-year institution using state financial aid but left before completing. (10,000+)
- Students enrolled in institutions on a two- or four-year path who are facing dismissal for academic reasons. (Unknown)

• Our current enrollment performance according to our website:

404,300+ users have visited the website.

50,870+ users completed the application.

15,280 have actually enrolled in a training program.

5,760 have completed a training program.

The services sought in this RFP are to support the Commission with its obligations under this project and this law, including the targeted outreach, triage of responses and the reporting of data to the General Assembly.

Selected agency will have demonstrated ability to perform this work in-house or work closely with a vendor that specializes in data analytics in the higher education space.

# 1.7 QUESTION/INQUIRY PROCESS

If it becomes necessary to revise any part of this RFP, or if additional information is necessary for a clearer interpretation of provisions of this RFP prior to the due date for proposals, an addendum will be posted to the website as well. The Commission may extend the due date and time of proposals to accommodate such additional information requirements, if required.

#### 1.10 PRICING

Pricing on this RFP must be firm and remain open for a period of not less than 180 days from the proposal due date. Any attempt to manipulate the format of the document, attach caveats to pricing, or submit pricing that deviates from the current format will put your proposal at risk. If the proposal is accepted, the pricing must remain firm during the term of the contract unless the scope of work required by the Commission changes.

### 1.11 CONFIDENTIAL INFORMATION

Respondents are advised that materials contained in proposals are subject to the Access to Public Records Act (APRA), IC 5-14-3 *et seq.*, and, after the contract award, the entire RFP file may be viewed and copied by any member of the public, including news agencies and competitors. Respondents claiming a statutory exception

to the APRA must indicate so in the Cover Letter. Confidential Information must also be clearly marked. The Respondent must also specify which statutory exception of APRA that applies. The State reserves the right to make determinations of confidentiality. If the Respondent does not identify the statutory exception the Procurement Division will not consider the submission confidential. If the State does not agree that the information designated is confidential under one of the disclosure exceptions to APRA, it may seek the opinion of the Public Access Counselor. Prices are not confidential information.

# 1.12 TAXES

#### 1.13 SECRETARY OF STATE REGISTRATION

#### 1.14 PAYMENTS

Invoices must detail expenses and charges in accordance with any purchase orders issued; total payment shall not exceed accepted bid amount. #### 1.15 COMPLIANCE CERTIFICATION

Responses to this RFP serve as a representation that it has no current or outstanding criminal, civil, or enforcement actions initiated by the State, and it agrees that it will immediately notify the State of any such actions. The Respondent also certifies that neither it nor its principals are presently in arrears in payment of its taxes, permit fees or other statutory, regulatory or judicially required payments to the State. The Respondent agrees that the State may confirm, at any time, that no such liabilities exist, and, if such liabilities are

discovered, that State may bar the Respondent from contracting with the State, cancel existing contracts, withhold payments to setoff such obligations, and withhold further payments or purchases until the entity is current in its payments on its liability to the State and has submitted proof such as payment to the State.

#### 1.16 CONFLICT OF INTEREST

Any person, firm or entity that assisted with and/or participated in the preparation of this RFP document is prohibited from submitting a proposal to this specific RFP. For the purposes of this RFP "person" means a state officer, employee, special state appointee, or any individual or entity working with or advising the State or involved in the preparation of this RFP proposal. This prohibition would also apply to an entity who hires, within a one-year period prior to the publication of this RFP, a person that assisted with and/or participated in the preparation of this RFP.

#### 1.17 EQUAL OPPORTUNITY COMMITMENT

Pursuant to IC 4-13-16.5 and in accordance with 25 IAC 5, Executive Order 13-04 and IC 5-22-14-3.5, it has been determined that there is a reasonable expectation of minority, woman, and Indiana veteran business enterprises subcontracting opportunities on a contract awarded under this RFP. Therefore, a contract goal for Minority Business Enterprises, Woman Business Enterprises, and Veteran Business Enterprises have been established and all respondents submitting a MWBE or IVOSB Subcontractor Commitment Form will be expected to comply with the regulation set forth in 25 IAC 5, Executive Order 13-04 and IC 22-14-3.5.

#### 2.2 COVER LETTER

The Cover Letter must address the following topics.

#### 2.2.1 Agreement with Requirement listed in Section 1

The Respondent must explicitly acknowledge understanding of the general information presented in Section 1 and agreement with any requirements/conditions listed in Section 1.

# 2.2.2 Summary of Ability and Desire to Supply the Required Products or Services

The Cover Letter must briefly summarize the Respondent's ability to supply the requested products and/or services that meet the requirements defined in Section 2.4 of this RFP. The letter must also contain a statement indicating the Respondent's willingness to provide the requested products and/or services subject to the terms and conditions set forth in the RFP including, but not limited to, the State's mandatory contract clauses.

# 2.2.3 Signature of Authorized Representative

A person authorized to commit the Respondent to its representations and who can certify that the information offered in the proposal meets all general conditions including the information requested in Section 2.3.2, must sign the Cover Letter. In the Cover Letter, please indicate the principal contact for the proposal along with an address, telephone and fax number as well as an e-mail address, if that contact is different than the individual authorized for signature.

# 2.2.4 Respondent Notification

#### 2.3.1 Terms

Funding for this project will come from state funds. Vendors must be able to agree to the terms and conditions of the Commission's standard Professional Services Agreement. All payments will be 35 days in arrears and via ACH/electronic deposit from the Indiana Auditor of State's Office. Invoices must detail expenses and charges in accordance with any purchase orders issued; total payment shall not exceed the accepted bid amount. Any and all travel reimbursed via this contract will be subject to the reimbursement rates in the State Travel Policy (vendors should review it on the following website <a href="http://www.in.gov/idoa/2459.htm">http://www.in.gov/idoa/2459.htm</a>).

#### 2.3.2 Registration to do Business

#### 2.3.3 References

The Respondent must include a list of at least three clients for whom the Respondent has provided products and/or services requested in this RFP. Information provided should include

#### 2.3.4 Subcontractors

The Respondent is responsible for the performance of any obligations that may result from this RFP, and shall not be relieved by the non-performance of any subcontractor. Any Respondent's proposal must identify all subcontractors and describe the contractual relationship between the Respondent and each subcontractor. Either a copy of the executed subcontract or a letter of agreement over the official signature of the firms involved must accompany each proposal.

Any subcontracts entered into by the Respondent must be in compliance with all State statutes, and will be subject to the provisions thereof. For each portion of the proposed products or services to be provided by a subcontractor, the Business Proposal must include the identification of the functions to be provided by the subcontractor and the subcontractor's related qualifications and experience.

The combined qualifications and experience of the Respondent and any or all subcontractors will be considered in the State's evaluation. The Respondent must furnish information to the State as to the amount of the subcontract, the qualifications of the subcontractor for guaranteeing performance, and any other data that may be required by the State. All subcontracts held by the Respondent must be made available upon request for inspection and examination by appropriate State officials, and such relationships must meet with the approval of the State.

The Respondent must list any subcontractor's name, address and the state in which formed that are proposed to be used in providing the required products or services.
