# SESSION OVERVIEW



## 2022 SESSION OVERVIEW

The General Assembly adjourned Sine Die in the early hours of Wednesday, March 9.

A total of 849 bills were filed this Session with just **265 surviving** the first half.

Only 178 of the remaining 265 bills were sent to the Governor for his signature





## 2022 SESSION OVERVIEW

We were tracking **126 bills** which directly impacted K-12 and postsecondary education.

 Only 46 of those bills survived to the second half with 37 bills making it to the Governor's desk.

Just five bills modify or create new legislative task for the Commission.

# HIGHER EDUCATION BILLS



## SEA 89: HIGHER EDUCATION SCHOLARSHIPS

This is the Commission's agenda bill and includes two items:

- Converts the Commission's student teaching stipends to traditional scholarships
- Updates Indiana Code language to account for the upcoming Free Application for Federal Student Aid (FAFSA) changes



#### SEA 82: FAFSA

- The bill no longer requires high school seniors to file the FAFSA or affirmatively opt-out.

#### The bill requires the Commission to update the model FAFSA notice provided to high school seniors with information about financial aid

### SEA 91: TEACHER PREPARATION PROGRAMS

- Indiana Code requires teacher preparation programs to report how their admission practices align with the standards set by the Council for the Accreditation of Educator Preparation.
- The bill allows teacher preparation programs to align admission practices with the standards set by the Association for Advancing Quality in Educator Preparation (AAQEP).

## SEA 366: HIGHER EDUCATION FUNDING

- Working Group are included in this bill.

### HEA 1045: 529 COLLEGE SAVING ACCOUNTS

The increase is estimated to reduce state revenues by \$28.1 million



## HEA 1094: EDUCATION MATTERS

- The bill attempts to address the issue of employer liability when providing work-based learning opportunities at the secondary level.
- The Department of Education (IDOE) is required to issue an RFP to find a company to provide liability insurance and workers compensation insurance for these experiences.
- IDOE does not have to enter into the agreement if the responses to the RFPs are not deemed "satisfactory."







#### HEA 1190: FREE SPEECH AT STATE INSTITUTIONS

- around free expression on their campuses.
- protected expressive activities are prohibited.
- Further, institutions cannot deny any benefit or privilege to, or discriminate against, a religious, political, or ideological student organization for its protected expressive activity.

The bill outlines what state educational institutions can and cannot do

Institutions may not designate an area on campus as a place where





#### HEA 1190: FREE SPEECH AT STATE INSTITUTIONS

- policy in line with the bill.
- A student or student organization may bring a state-level civil suit against an institution for a violation of free speech rights.

## FREE SPEECH SURVEY

HEA 1549-2021 requires the Commission to work with the institutions to survey students on free expression on college campuses.

The Commission and the institutions worked with Gallup to develop a survey instrument which will launch in April.

The results of the survey will be available this summer and staff will provide the Commission with an update in the fall.







## HEA 1251: VARIOUS EDUCATION MATTERS

- The bill creates a K-12 adjunct teacher permit which allows school corporations to employ content experts to fill vacancies.
- Adjunct teachers must meet numerous requirements including four years of experience in the content area and being paired with a mentor teacher.
- Adjunct teachers cannot teach special education and school corporations must report information on their adjunct teachers to IDOE
