## MEETING MINUTES

### June 3, 2015

#### **Call to Order**

The Cass County Fire District 1 (CCFD1) Board met at 6:30 p.m. at Cass County Fire District 1 Station, at 1444 Holland Street, Logansport, Indiana. Meeting was called to order at 6:31 p.m. by Chairman Karl Myer. Board members present were Karl Myer, Dave Patty, and Fiscal Officer Bridget Enyeart. Michael L. Sims was excused.

#### **Secretary's Report**

Meeting Minutes of May 6, 2015 and May 26<sup>th</sup> 2015 were reviewed. Dave Patty made a motion to accept the minutes. Karl Myer seconded the motion. ***Motion passed 2-0.***

#### **Treasurer's Report/ Payment of Claims**

Treasurer's Report was given by the Fiscal Officer, Bridget Enyeart. Claim submitted totaled \$65,902.27. The checking account balance reported after claims were submitted is \$44,994.76; the savings account balance is \$138,864.68. The current balance in the Building Debt Fund is \$2,377.353. The current balance in the Emergency Loan Fund is \$1567.93. The current balance in the Fire General Fund is \$105,699.25 and the current balance in the Cumulative Fire Fund is \$74,214.73. Karl Myer made a motion to accept the Fiscal Officers report and claims as read. Dave Patty seconded. ***Motion passed 2-0.***

#### **Fire Chief's Report**

1. Run Report was given.
2. We have heard nothing new regarding the ladder bill from Fire Service Inc. in the amount of \$15,004.48.
3. Fire Chief updated members on status of locating another engine Fire Chief will keep board members informed on any updates.
4. Quote for replacement tires were submitted and reviewed.
5. Quote for replacement equipment was reviewed and discussion was held regarding applying for grants to assist with replacement equipment expenses. Board members will attend Community Foundation Grant Writing Workshop.
