The Indiana Department of Child Services (DCS) has investigated the report of suspected child abuse and/or neglect explained below. ## Child Care Worker Investigation Review (CCWIR)

Before the decision to substantiate the allegations is finalized, you have the opportunity to meet with a DCS administrator not involved in making the recommendation. This meeting will allow you to respond to the allegations and the basis of proposed decision. You may have an attorney, or other representative, take part in this meeting. You **will not** be permitted to present or cross-examine witnesses. However, you can give your own account of the incident and provide written statements and documents. After the CCWIR, you will be given written notice of the decision and an explanation of the administrative appeal hearing process.

You do not have to take part in the CCWIR. The CCWIR provides you with an opportunity to present any information that you believe could help DCS make the most accurate decision regarding the allegations of child abuse and/or neglect summarized in this notice. However, if you choose not to participate in the CCWIR, DCS may substantiate the allegations of child abuse or neglect against you as the perpetrator, based on the information obtained during the investigation and place your name on the Central Client Index.

Regardless of whether you participate in the CCWIR, you will be sent written notice of the final decision and an explanation of the expedited and regular administrative appeal process. Additionally, you retain your right to appeal the Department's final decision whether or not you participate in the CCWIR.
