MINUTES OF MEETING
March 10, 2022

The Members of the Department of Financial Institutions met at 10:00 a.m., EDT, at 30 South Meridian Street, Suite 300, Indianapolis, Indiana. Present from the Department were Thomas C. Fite, Director; Christopher Dietz, Deputy Director, Depository Division; Michael Fracassa, Deputy Director, Administration Division; Nicole Buskill, General Counsel and Secretary; George Dremonas, General Counsel; Kirk J. Schreiber, Senior Depository Analyst and Assistant Secretary; Scott Imbus, Field Supervisor; Kristy Hubele, Field Manager; and Sharmaine Stewart, Administrative Assistant. Also present was Jeremy Hill, Attorney with Dentons Bingham Greenebaum LLP.

I. EXECUTIVE SESSION: 10:00 a.m.

- A. Discussion of records classified as confidential by state or federal statute, authorized under Ind. Code § 5-14-1.5-6.1(b)(7). The Members certify that no subject matter was discussed in the Executive Session other than the subject matter specified in the public notice.

II. PUBLIC SESSION: 10:27 a.m.

- A. Members Physically Present: Richard J. Rice, Chairman; Thomas C. Fite, Director; Jean Wojtowicz and Donald E. Goetz.; Present via Web Ex were Mark Schroeder, Vice Chairman and Benjamin Bochnowski.

- C. Chairman Rice entertained a motion to approve the minutes of the February 10, 2022 meeting.

Ms. Wojtowicz moved approval of the minutes; Mr. Goetz seconded the motion and the motion passed unanimously.

Ms. Buskill called roll for the vote. Rick Rice, Mark Schroeder, Jean Wojtowicz, Ben Bochnowski, Don Goetz, and Tom Fite all voted yes. The minutes were approved 6-0.

D. DEPOSITORY DIVISION:

1. First Merchants Bank, Muncie, Delaware County, Indiana

Ms. Wojtowicz abstained from the discussion and voting on this application and stepped out of the room due to her relationship as director of First Merchants Bank and First Merchants Corporation.

Mr. Kirk J. Schreiber, Senior Depository Analyst presented this application. Representing First Merchants Bank was Jeremy Hill, Attorney, Dentons Bingham Greenebaum LLP. Mr. Schreiber informed the Members that First Merchants Bank and Level One Bank, Farmington Hills, Michigan propose to effect a merger pursuant to IC 28-1-7 and IC 28-2-17-20.

First Merchants Bank will survive the merger. Immediately prior to the bank merger First Merchants Corporation, the financial holding company of First Merchants Bank, will directly acquire Level One Bancorp, Inc., the holding company for Level One Bank. The acquisition of Level One Bancorp, Inc. by First Merchants Corporation does not require the Members approval due to the merger transaction complying with the exemption provisions of IC 28-2-14-15.

Following the holding company acquisition and bank merger, First Merchants Corporation will be a one bank holding company with First Merchants Bank as its wholly owned bank subsidiary. Level One Bank's main office and branches will be branches of First Merchants Bank. The corporate existence of Level One Bank and Level One Bancorp, Inc. will cease.

Mr. Schreiber reviewed and informed the Members that each of the statutory requirements of IC 28-1-7 and 28-2-17-20 had all been satisfactorily met.

A motion for approval of the merger application of First Merchants Bank was made by Mr. Schroeder and seconded by Mr. Goetz.

Ms. Buskill called roll for the vote. Rick Rice, Mark Schroeder, Don Goetz, Ben Bochnowski and Tom Fite all voted yes. The application was approved 5-0.

E. DIRECTOR'S COMMENTS AND ACTIONS:

1. Legislative Update

Nicole Buskill, General Counsel, presented the Members a legislative update stating that the DFI bill passed both houses and that the Governor had already signed the bill. There were no amendments to the bill in the House.

Buskill stated that the DFI watched various other bills including SB 371 - the Replacement of the London Interbank Offered Rate and SB 408 - the Community Investments by Financial Institutions, both of which passed.

The DFI also monitored SB 352 which sought to amend portions of Chapter 3 to allow for an installment loan product. Buskill stated that the bill passed out of the Senate but did not receive a hearing in the House. Buskill stated that she anticipates that another bill, similar in nature, will be introduced again next year.

Buskill also mentioned that the DFI is concerned about HB 1100, which sought to amend rule making authority. The Governor's office asked the DFI to testify at the Senate hearing, but the Senate committee did not allow any party to testify in opposition to the bill. Senator Perfect, chairman of the committee, concluded the HB 1100 hearing by stating that the bill was not ready and would not move out of the senate committee. However, after declining to allow testimony in opposition to the bill, the Legislature amended similar language into HB 1211, a blockchain bill, during a conference committee. If the bill is not vetoed, the DFI will be required to submit its two rules to a legislative committee every 90 days for reapproval. Buskill stated that if a deadline is missed or the legislative committee does not timely approve the rule extensions then the DFI's two emergency rules will expire.

2. Director Fite advised the Members of actions taken pursuant to Delegated Authority.

OTHER BUSINESS:

Chairman Rice asked if there was other business. There being no further business, Chairman Rice entertained a motion to adjourn the meeting. Mr. Fite moved for adjournment, Mr. Goetz seconded the motion, and it passed unanimously.
