# DEPARTMENT OF FINANCIAL INSTITUTIONS MINUTES OF MEETING July 14, 2022

The Members of the Department of Financial Institutions met at 10:00 a.m., EDT. Present from the Department were Thomas C. Fite, Director; Michael Fracassa, Deputy Director, Administration Division; George Dremonas, General Counsel; Kirk Schreiber, Senior Depository Analyst and Assistant Secretary; Scott Imbus, Field Supervisor; Luke VanNatter, Project Manager; Asha Cermak, Summer Intern and Sharmaine Stewart, Administrative Assistant. Also present virtually via Microsoft Teams was Travis Markley with Hoosier Hills Credit Union.

#### I. PUBLIC SESSION: 10:00 a.m.

- A. Members Present: Mark Schroeder, Vice Chairman; Thomas C. Fite, Director; Jean Wojtowicz, Donald E. Goetz and Benjamin Bochnowski. Richard J. Rice, Chairman was present virtually via Microsoft Teams.
- **B.** Date of next meeting: August 11, 2022 @ 10:00 a.m., at the Indiana Department of Financial Institutions, 30 South Meridian Street, Suite 300, Indianapolis, Indiana.
- C. Vice Chairman Schroeder entertained a motion to approve the minutes of the June 9, 2022 meeting.

Ms. Wojtowicz moved approval of the minutes; Mr. Bochnowski seconded the motion and the motion passed unanimously.

Mr. Schreiber called roll for the vote. Richard Rice, Mark Schroeder, Jean Wojtowicz, Don Goetz, Ben Bochnowski and Tom Fite all voted yes. The minutes were approved 6-0.

- **D.** Election of Officers as stipulated in IC 28-11-1-8 and any other organizational matters.
  - 1. Election of Vice-Chairman- Mark A. Schroeder
  - 2. Election of Secretary-Nicole Buskill
  - 3. Election of Assistant Secretary- Kirk J. Schreiber

Mr. Goetz moved approval to keep in place the current slate of officers. Ms. Wojtowicz seconded the motion. There were no further nominations nor discussion on the matter. The motion passed unanimously.

Mr. Schreiber called roll for the vote. Richard Rice, Mark Schroeder, Jean Wojtowicz, Don Goetz, Ben Bochnowski and Tom Fite all voted yes. The nominations were approved 6-0.

#### E. DEPOSITORY DIVISION:

#### 1. Hoosier Hills Credit Union, Bedford, Lawrence County, Indiana

Mr. Kirk J. Schreiber, Senior Depository Analyst presented this application. Representing Hoosier Hills Credit Union was Travis Markley, President and CEO of Hoosier Hills Credit Union. Mr. Schreiber informed the Members that Hoosier Hills Credit Union ("Hoosier Hills") and Dearborn County Federal Credit Union, Lawrenceburg, Dearborn, County, Indiana ("DCFCU") propose to effect a merger pursuant to IC 28-7-1-33.

Hoosier Hills and DCFCU entered into a proposed merger agreement dated February 25, 2022 which was executed March 29, 2022. Hoosier Hills will survive the merger and DCFCU main office will become a branch of Hoosier Hills. As a part of the merger, Hoosier Hills approved field of membership already includes Dearborn County and therefore will not have to seek an expansion to its existing field of membership.

Mr. Schreiber informed the Members that each of the statutory requirements of IC 28-7-1-33 had all been satisfactorily met.

A motion for approval of the merger application of Hoosier Hills Credit Union was made by Mr. Goetz and seconded by Mr. Rice.

Mr. Schreiber called roll for the vote. Richard Rice, Mark Schroeder, Jean Wojtowicz, Don Goetz, Ben Bochnowski, and Tom Fite all voted yes. The application was approved 6-0.

#### F. CONSUMER CREDIT DIVISION:

#### 1. <u>Adoption of Indiana Uniform Consumer Credit Code Dollar Amount Adjustments</u> <u>Emergency Rule.</u> (Asha Cermak)

Legal Intern, Asha Cermak, on behalf of the Consumer Credit Division, presented a resolution to the Members to adopt emergency rule 750 IAC 1-1-1 ("Dollar Amount Adjustments"). Cermak presented the Dollar Amount Adjustments as part of the Department's administrative rules that list specific dollar amounts in the Indiana Uniform Consumer Credit Code and the Home Loan Practice Act and is set to be amended every odd-numbered year.

Cermak noted that the dollar amounts listed in the Rule are amended based on the Consumer Price Index, published by the U.S. Department of Labor. The emergency rulemaking procedure exists because the data required for the dollar amount adjustments is generally not available early enough to use standard rule making procedures.

Cermak presented the Members with: (1) the Rule with the adjusted dollar amounts and (2) a proposed Resolution. Cermak also asked the Members to authorize the Director to execute and file any documentation required to adopt the rule.

Jean Wojtowicz motioned to approve the Resolution, and Benjamin Bochnowski seconded the motion.

Mr. Schreiber called roll for the vote to approve the Resolution. Richard Rice, Mark Schroeder, Jean Wojtowicz, Don Goetz, Benjamin Bochnowski, and Tom Fite all voted yes. The Resolution was approved 6-0.

#### G. DIRECTOR'S COMMENTS AND ACTIONS:

#### 1. Delegation of Authority

The Members approved a revised Delegation of Authority Order at a meeting on December 22, 2021. Luke VanNatter informed the Members about improvements in licensing processes for MLO's that resulted from the revised Delegation of Authority.

George Dremonas proposed a new Delegation of Authority Order, which grants the Director the ability to further delegate the approval of certain MLO applications to consumer credit staff. The proposed Delegation of Authority Order (a) permits MLO applicants who have lived outside of the United States for a period of time to submit an affidavit regarding the applicant's criminal history and (b) permits staff to designate applications as approved but inactive for MLO applications that meet all licensing criteria, except for not having a qualifying sponsoring employer. Dremonas stated that the reason for the change is to further improve the licensing process.

After discussion, Jean Wojtowicz motioned to approve the proposed Delegated Authority Order, as amended, and Don Goetz seconded the motion.

Kirk Schreiber called roll for the vote to approve the Delegated Authority Order, as amended. Richard Rice, Mark Schroeder, Jean Wojtowicz, Don Goetz, Ben Bochnowski and Tom Fite all voted yes. The Order was approved 6-0.

- 2. Director Fite advised the Members of actions taken pursuant to Delegated Authority.
- 3. Director Fite discussed a few items under other matters. Director Fite noted he and Deputy Director Michael Fracassa had a meeting with the Budget Agency about the Department's budget and strategic plan. The meeting went well and ongoing discussions with the Budget Agency will continue.

Additionally, Director Fite noted items that possibly could have ramifications on Indiana institutions that are being discussed in Congress. The main discussion is about charter

types including Industrial Loan and Investment Companies ("ILC") charters and their reasons for existing as a financial institution.

Mr. Bochnowski talked about his recent visit to Washington D.C. with the Indiana Bankers Association ("IBA") contingent. Mr. Bochnowski noted the session with the FDIC Chairman and the discussion about the possibilities of a recession and what area federal regulators were focusing on for their examinations. He also mentioned the discussion the IBA had with legislatures about climate risk.

#### **OTHER BUSINESS:**

Vice Chairman Schroeder asked if there was other business. There being no further business, Vice Chairman Schroeder adjourned the meeting.
