<p>(1) Change APPROVED to read as follows: APPROVED means, as to materials, equipment, appliances, methods of design, and types of construction, acceptance by the building official by one (1) of the following methods:</p> <ul style="list-style-type: none"> (1) investigation or tests conducted by recognized authorities; (2) investigation or tests conducted by technical or scientific organizations; or (3) accepted principles. <p>The investigation, tests, or principles shall establish that the materials, equipment, appliances, methods of design, and types of construction are safe for their intended purpose.</p> <p>(2) Delete the definition of KITCHEN and substitute to read as follows: An area with a sink and permanent facilities for food preparation and cooking.</p> <p>(3) Delete the definition of LABELED and substitute to read as follows: LABELED. Equipment or materials to which has been attached a label, symbol, or other identifying mark of an organization engaged in product evaluation that maintains periodic inspection or of production of labeled equipment or materials and by whose labeling the manufacturer indicates compliance with appropriate standards or performance in a specified manner.</p> <p>(4) Delete the definition of LISTED AND LISTING and substitute to read as follows: LISTED AND LISTING. Equipment or materials included in a list published by an organization engaged in product evaluation that maintains periodic inspection of production of listed equipment or materials and whose listing states either that the equipment or material meets appropriate standards or has been tested and found suitable for use in a specified manner.</p> <p>(5) Add a definition of NATIONAL ELECTRICAL CODE after MULTIPLE STATION SMOKE ALARM to read as follows: NATIONAL ELECTRICAL CODE means the Indiana Electrical Code (675 IAC 17).</p> <p>(6) Change the definition of RECESSED LIGHT after RECEPTOR to read as follows: RECESSED LUMINAIRE. For purposes of Chapter 11, RECESSED LUMINAIRE means a luminaire that by design penetrates the thermal boundary of the building.</p>
