Delete Chapter 1 and substitute Chapter 1 from the 2005 Indiana Residential Code (amendments) with the following changes to the existing Indiana amendments.

Adoption by reference; title; purpose.

Sec. 1. (a) Those certain documents titled the ~~2003~~ 2009 International Residential Code for One and Two Family Dwellings, ~~fifth~~ first printing, published by the International Code Council, ~~5203 Leesburg Pike, Suite 708, Falls Church Virginia 22041-3401~~ 4051 West Flossmoor Road, Country Club Hills, Illinois, 60478, are hereby adopted by reference as if fully set out in this rule save and except those revisions made in this rule.

(b) This rule shall be:

- (1) known as the Indiana Residential Code, ~~2005~~ 2009 edition; and
- (2) published, except incorporated documents, by the department of homeland security for general distribution and use under that title. Wherever the term "this code" is used throughout this rule, it shall mean the Indiana Residential Code, ~~2005~~ 2009 edition.

(balance of Chapter 1 amendments unchanged)

**REASON**

This proposed amendment brings the current 2005 Indiana amendment language to the new rule. Changes are made to the edition year, the Chapter 43 reference has been dropped in favor of the current chapter of the new IRC edition and the address of the ICC is changed to reflect the address listed on ICC's IRS Form 990. The proposal lists the first edition of the 2009 IRC although that may change by the time the rule is finalized.

**Fiscal Impact of this change:** Fiscal impact would be that of the overall cost of the adoption of the new rule and is undetermined at this time.
