SUBJECT MATTER OF THE RULE:

Amends 675 IAC 28-1-12 to update the 2011 edition of NFPA 25, National Fire Protection Association Standard for the Inspection, Testing, and Maintenance of Water-Based Fire Protection Systems, and make conforming changes. Effective 30 days after filing with the Publisher.
