LSA DOC. #12-51 - NFPA 10, 2010 edition

SUBJECT MATTER OF THE RULE:

Amends 675 IAC 28-1-2 to update the 2010 edition of the NFPA 10, National Fire Protection Association Standard for Portable Fire Extinguishers, and make conforming changes. Repeals 675 IAC 22-2.2-11 (NFPA 51A), 675 IAC 28-1-14 (NFPA 34), and 675 IAC 28-1-20 (NFPA 51B). Effective 30 days after filing with the Publisher.
