

IDHS Approved ICS Instructors

This list is not all-inclusive and will be updated periodically as we approve additional ICS instructors. Instructors have completed the ICS 100-400, 700, and 800 courses, have attended an ICS train-the-trainer course, have ICS experience on a multi-jurisdiction or multi-operation period incident, and have adult education experience. All instructors are qualified to teach ICS 100, 200, 300, 400, and 402 (ICS for Executives). If your instructor's name is not on this list, he/she should provide a copy of his/her qualification records. All ICS instructors are required to meet the following standards as set forth by the USDHS:

Instructors should not charge students to attend an ICS class, as materials (manuals, tests, and certificates) will be provided by the Center for Domestic Preparedness (CDP) using federal tax dollars. A small fee (NOT MORE THAN \$25/HR) may be charged to the requesting host agency to cover the instructor's time out of office if his/her employer will not pay for the instructor's time. ICS instruction is not intended to be a for-profit endeavor.

To ensure nationwide consistency, all classroom times are USDHS-standard minimum contact time (excluding breaks). Additional time may be needed to complete these courses.

ICS 100: Introduction to the Incident Command System (8 hrs)

ICS 200: ICS for Single Resources and Initial Action Incidents (12.5 hrs)

ICS 300: Advanced ICS for Expanding Incidents (18 hrs)

ICS 400: ICS for Command and General Staff (14 hrs)

ICS 402: ICS for Executives/Senior Officials (2 hrs)
