REPORT OF THE CHAIR

Chairman Garvey welcomed everyone to the meeting and the Indiana Emergency Response Conference.

COMMITTEE REPORTS

Communications Committee—Sherman Greer, Chair

Mr. Greer is pleased with this year's IERC/LEPC conference. We are starting to make preparations for the 2013 conference.

Question on the floor how can we get more people to come to conference? Funding can be used to attend conferences looking at not allowing if not 51% haz-mat content.

Policy/Technical Committee—James Pridgen/Dean Larson, Co-Chairs

Mr. French asked certain questions regarding;

- 1) Members asking about LEPC/IDHS meetings October/November is retreat time.
- 2) How should LEPC be organized in the State and
- 3) What can we do to benefit the state?

We need to focus on taking care of the citizens in Indiana, we have a great deal of money not being tapped.

Allow the State to allocate monies to the compliant LEPC's that are doing their job. Mr. French would like by December 2013 for all LEPCs to be compliant.

Mr. French recommended to build an infrastructure for teleconferences and surveys.

Policy procedures training identified a major lack in paperwork, equipment concerns such as the maintenance of the equipment

- State Training Ethics training submit dates get instant notification Motion made by Mr. Goff, second by Mr. Palin, MOTION CARRIED
- Indiana State travel requirements, MOTION TABLED

NEW BUSINESS

- Chief Lott, suggested allowing LEPCs to pay for their Haz-Mat Alliance dues which is \$200.00 per year and stated members should be free.
- There are 44 active Hazard teams across the State. District 5 Hazmat task force are identifying individuals with skills would like to become more involved with LEPC's, 17 teams have went through the evaluation process. Only compliant counties (LEPC) are entitled to that funding. No criteria established, there is a need for a guidance document.
- Jerry Nulliner with the Indiana Alliance of Hazardous Materials Responders talked to the commission about how the IERC and the Indiana Haz-Mat Alliance could work together in training.

The following non-compliant LEPC's have not been responsive to his attempts to bring them into compliance but will continue to reach out to county officials: Receiving no response.

- LEPC Status Table (2005 2012 funding years) for this year 2012 there were 73 funded and in compliance.
- Training Computer-Aided Management of Emergency Operations (CAMEO) class is 5 hours would like to have it for an entire day.

LEPC ONLINE REPORTING

The online reporting system is nearing completion and has been beta tested and will be demonstrating at the conference. Once completed this system will address issues such as LEPC roster changes, ethics training, fiscal reports, HSEEP compliant exercises.

Completion of this system as follows;

- 1. Refining for the next 2 weeks
- 2. LEPC for field testing
- 3. Develop how to document for LEPCs and formally announce use of online reporting
- 4. Issue/release user-IDs/passwords to all active LEPCs in November
- 5. Implement January 1, 2013
