5. **Describe** the candidate's efforts to ensure the competency in patient care given by EMS personnel acting under his authority or established protocols.
6. **Describe** the candidate's involvement in the development of protocols for his/her EMS affiliates.
7. **Describe** the candidate's efforts to establish and/or improve the relationships between EMS personnel and receiving facilities, other physicians, and other members of the medical community.
8. **Describe** the candidate's efforts promote the importance of establishing an effective system of pre-hospital emergency

medical care to the general public and local government officials.

9. **Describe** the candidate's activities to improve the quality and level of patient care offered by affiliated EMS provider organizations.
10. **List** any other involvement in community activities or organizations that show a desire to improve the health and welfare of local citizens.
11. In your own words, **tell** why you believe this candidate should be chosen Medical Director of the Year.
