Featured Speaker

Foria Younis is the founder and CEO of South Asia Middle East (SAME) Consultants. Prior to launching SAME Consultants Ms. Younis was a Special Agent for the Federal Bureau of Investigation (FBI) on the joint terrorism task force (JTTF) in the New York Office.

During her ten year career with the FBI, Ms. Younis contributed to several high-profile investigations to include, the 1998 bombings of American Embassies in East Africa, the crash of TWA flight 800, the 2000 attack on the USS Cole in Yemen, the kidnapping and subsequent murder of The Wall Street Journal reporter Daniel Pearl and the 9/11 attacks in the United States. These investigations have taken her throughout the Middle East, South Asia and the rest of the world.

In 2003, Ms. Younis was the recipient of the Director's Annual Award for "Outstanding Counter Terrorism Investigation."

In the post 9/11 climate Ms. Younis developed a course of instruction titled "Muslim Culture for Law Enforcement." The course has been taught to thousands of law enforcement officers and military personnel in the United States and abroad. Ms. Younis has successfully assisted many United States and foreign law enforcement organizations with regional and cultural specific investigations. Ms. Younis is considered an expert on the region and culture.

> Important Information <

This training is *free* to all state, county, and local law enforcement agencies. **Two nights** lodging will be paid for state, county, or local law enforcement only (employees of the federal government or private corporations are not eligible). For lodging to be covered, the eligible attendees must live more than 50 miles from the conference location. Attendees staying more than two nights are responsible for the extra night's expense. Those who register and *do not* attend will be responsible for the registration fee and/or the lodging expense if not cancelled by the required deadlines. Mileage and per diem will not be covered and are the responsibility of the individual or agency.

Lodging will be at the **Sheraton Hotel at Keystone at the Crossing** in Indianapolis. Participants are responsible for making their own room arrangements.
