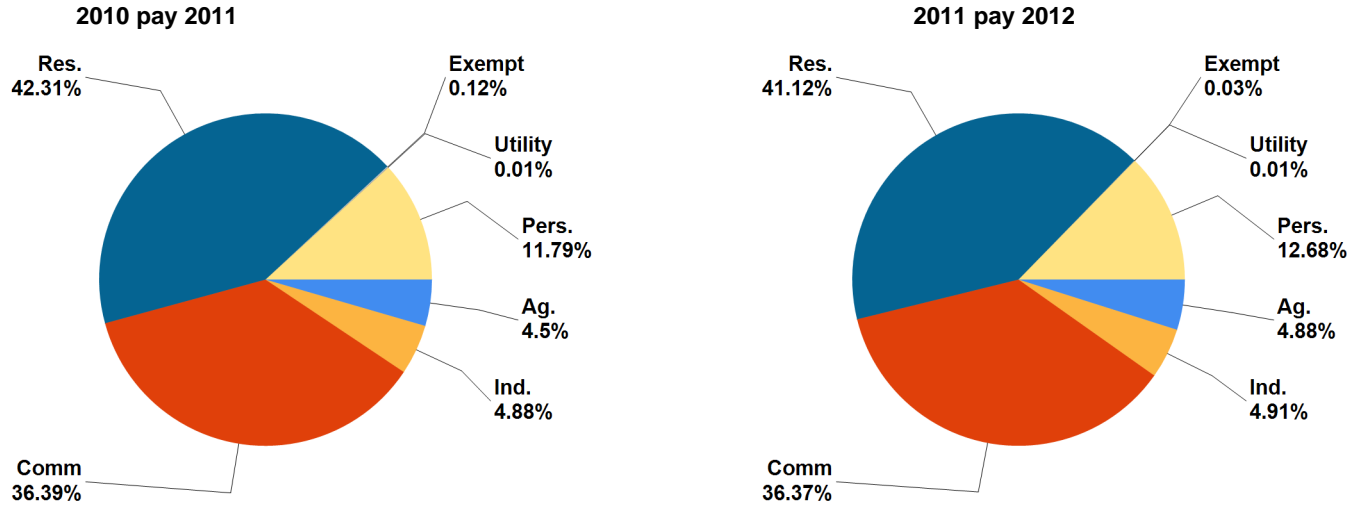
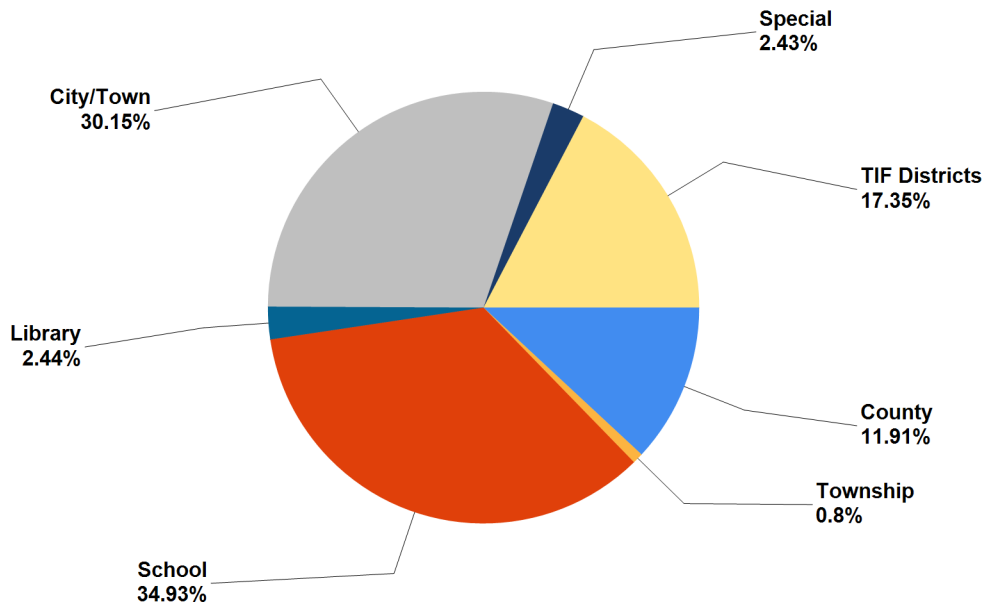

Who Receives Property Taxes?

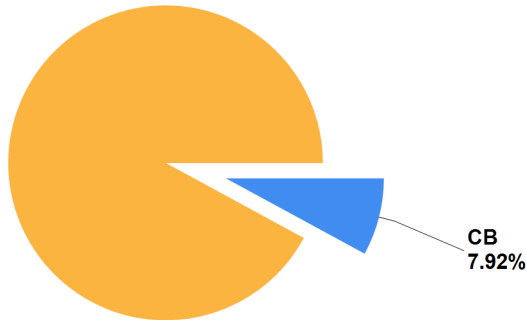


Who Receives Circuit Breaker Credits?

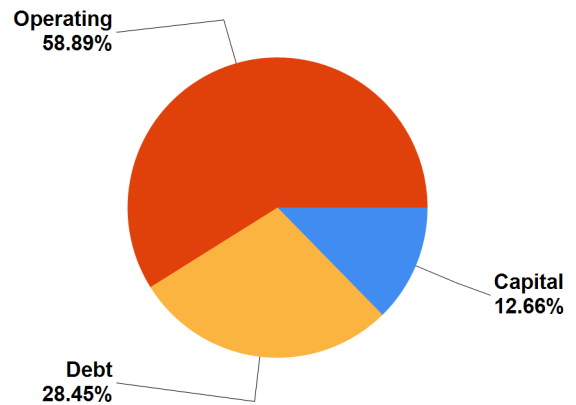
